Subject: - Permission for Optical Fiber Cables along Bahadurgarh to Rohad via Bamnoli, Kanonda, Kulasi, Jassour Kheri & Dehkora Total Length 23.500 Km.

In-continuation of this office memo No. 123 dated 12/01/2016

Date of start of road cutting:- 02/02/2016.

Date of completion of service laying is :- 02/02/2017.

Road cutting permission for the above mentioned subject has been granted as

under: -

- 1. The work shall be carried out in such a manner so as not to effect or disturb any service coming along the work.
- 2. The agency shall make arrangement for necessary barricading during the execution of work.
- 3. The work shall be carried out as per the alignment approved and as per direction of the Engineer-In-Charge. There should not be any deviation from approved alignment.
- 4. The agency should lay cable/service at least 1.5. meter below road surface. If later the department decides to charge fees for usage of land by the cable/service, then the agency should be ready to pay this fees in future.
- 5. The agency has to use trench-less method for crossing bituminous road surface of main road.
- 6. The date of start for road cutting is 02/02/2016.. The date of completion is 02/02/2017. It the agency is unable to complete the work within this period, they have to obtain fresh permission from the department.

7. The agency shall be fully responsible for any damage done to the road. In case of damage to the road, agency will have to deposit cost for repair of this damage within 30 days. Fresh road cutting permission may be obtained from the department, if the agency has to do some repair work in its cable/service later.

- 8. The work shall be carried out without disturbing the flow of traffic and the road should not be completely closed without getting prior approved from the department.
- 9. The agency has to follow all standard conditions for road cutting.
- 10. All dismantled serviceable material shall be stacked properly along the sides of footpath and it will become the property of the department.
- 11. All trenches shall be filled by earth in layers and well rammed and consolidated after the completion of work. If the department will not be satisfied with the work, the agency has to deposit the additional amount for proper filling of the trenches.
- 12. Back filling of trench and its surface dressing should be done progressively during the execution of work.
- 13. The agency should take proper care not to damage surrounding during the execution of the work. The agency will be responsible for any damage or leakage.
- 14. If the department requires shifting of this cable/service in future due to widening/improvement works of the road, then the agency should do this shifting at its own cost within 60 days of being intimated by this department. The maximum available period for such shifting is 90 days.
