- (a) General Details :- Scheme is Prepared for 100 plants on Degraded Forest Land (DFL)
- (b) Spacing :- 5 mts X 5 mts
- (c) Species :- Ronj, Ber, Khair, Aanwla, Neem, Arjun, Churel etc.
- (d) Plantation method :- By manual pit digging and manual labor
- (e) Soil and Moisture conservation works :- As per Model.
- (f) Protection (fencing, watch man, People's Participation etc.) :- Tree guard
- (g) Proposal Monitoring mechanism :- By Field staff, DFO and evaluation Team of CCF and PCCF.
- (h) Any other information :- As per site condition minor variation may be from approved model rate.
