



5	Possession value of forest land diverted	30% of environmental costs (NPV) due to loss of forests or circle rate of adjoining area in the district should be added as a cost component as possession value of forest land whichever is maximum	The possession value of forest land diverted is calculated as Rs. 51.393 Lakhs. (30% of NPV) However, in case of transmission line projects, possession of diverted forest land is not completely required by the User Agency after completion of the project & during operation and maintenance (O &M) stage. 
