

SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF/ DFO

(for the forest land to be diverted under FCA)


A proposal has been received by this office from Proposed 0.3500 Hectare area for Indraprastha Gas Ltd project for Laying of 8 NB Carbon Steel Gas Pipeline, 125 mm MDPE & 50 mm Duct in same trench along Old NH-24(Hapur City Area (Left Side)) from Km.49.800 to Km. 54.00 & NH-235 (Meerut-Hapur Road (Left Side)) from Km.28.500 to Km.31.300 Total Km 7.00 & 0.3500' Ha. in Forest Division Hapur, District Hapur-UP on dated 17.02.2022 for diversion (under FCA-1980) of 0.0587 ha. of forest land for non forestry purpose. The project envisages the use of Protected Forest land in NH-24 Hapur – Garh Road for construction of Indraprastha Gas Ltd in Forest Division Hapur, District Hapur- UP. The site inspection of the land involved in the proposal has been done by me on 17.02.2022.

User Agency has proposed an alignment that requires 0.3500 Ha. forest land. **The proposal is recommended for approval.**

1. On inspection of the site, it is found that the forest land required by the user agency measuring 0.3500 ha. stated in column-2 of Part-I is **unavoidable and barest minimum required for the project.**
2. Whether any rare / endangered / unique species of flora & fauna is found in the area- **NIL**
3. Whether any protected archaeological/ heritage site/ defense establishment or any other important monument is located in the area- **NIL**
