
I submit that the work of “Improvements to Rayalpeta- Madhavaram road (via) Penugolakala from Km 0/0 to 16/0 in Chittoor District” was sanctioned under RIDF-XII for Rs 260.00 Lakhs and the same was entrusted to Sri N. Sreenath Reddy at 4.95% Excess vide CR agt No 44/2007-08. The work could not be carried out from Km 9/9 to 13/8 since the road is passing through reserve forest.

Improvements of this road from Km 9/9 to 13/8 (3.90 Kms) facilities in the **reductions of** more than 30.00 Km length for the people travelling from Peddapanjani(M) to Thavanampalli (M) and would further improve connectivity in terms of achieving smooth and safe traffic flow and improve level of service. In addition to above, substantial economic gain in terms of reduced Vehicle Operating Cost (VOC) and reduced travel time will be achieved. At present the road is earthen road passing through Reserve forest and diversion of 3.34 Ha of forest land is required for the purpose of improvements to the road.

I here with enclose the Proceedings of the District Collector, Chittoor and it was directed to Transfer an extent of Acs.11.89 cents or 4.79 Ha in S.No. 106 (carved out from Old. S.No. 85 of Kaigal village of Baireddipallemandal , Chittoor District in favour of Forest Department as compensatory afforestation on diversion of 5.70 Ha. of forest land.

In View of the above, it requested to forward the submission of proposals to the competent authority.
