NOTIFICATION

No. Fts (A) 7-19/86- Dated Shimla-2, the 27th April, 87.

Whereas the nature and extent of the rights of the Government and of private persons in or over the forest land and waste land specified in the Schedule appended to this Notification have been enquired into and recorded under sub-section(3) of the Section 29 of the Indian Forest Act, 1927, (Act No. 16 of 1927);

And whereas the forest land and waste land shown in the aforesaid Schedule are the properties of the Government or over which the Government has proprietary rights or the Government is entitled to the whole or any part of the forest produce thereof;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 29 of the said Act, the Governor, Himachal Pradesh is pleased to declare that the provisions of Chapter-IV of the said Act shall apply to the said forest land and waste land as specified in the aforesaid schedule and shall hereafter be called as "protected forests" under the provision of sub-section(2) of section 29 of the Act *ibid*.
