Memo;

This has reference to the Minutes of 16th meeting of REC of Integrated Regional Office Shimla Held on 21st February, 2023 issued vide File no 14-4/IRO/REC/2021/2/93 Dated 25 February 2023. On the subject cited above.

In this context, the Reply/ Compliance for each of the observation raised by REC, IRO Shimla, regarding the forest Proposal of Dubling Rishi Dogri-Lamche Dogri Road, is furnished as under:-

Sr. No.	Query	Compliances
1.	State Government shall ensure to restrict the felling of trees to maximum 122 trees in the diverted forest land. However, the possibility to reduce the number of trees (especially <i>Pinus gerardiana</i>) must be explored and the State Forest Department shall constitute a Committee comprising Range Officer and Site Engineer In-charge and headed by the DFO concerned. The Committee shall examine the alignment at the time of execution of work and will recommend the removal of trees on case-to-case basis along the Road. After looking into the possibility of reducing the total number of trees to be affected. The DFO shall verify the enumeration and accordingly grant felling permission based on the actual requirement. DFO will submit the list of trees to IRO Shimla, granted felling permission by him and trees to be retained. The undertaking for the same duly authenticated by the concerned DFO may be provided.	In this regard the Undertaking is attached as annexure R1.
2.	The FRA Certificate along with all prescribed annexure shall be submitted before Stage- II (Final) approval as per the MoEF&CC letter dated 16.02.2022 vide File No. FC- 11/76/2019-FC-Part (1). An Undertaking to submit the same before	In this regard the Undertaking is attached as annexure R2.

	Stage-11(Final) approval shall be submitted by the User Agency duly authenticated by concerned DFO.	
3.	State Govt. shall provide the documentary proof of showing the possession of CA land under the possession of H.P Forest Department.	The necessary certificate by the concerned DFO is attached as annexure R3
4.	State Govt. shall submit an undertaking to comply the order of Hon'ble High Court of Himachal Pradesh issued on 13.01.2023 in CWPII TO 13/2021 titled as Kusum Bali Vs States of HP and others. And accordingly, shall submit the NOC from Pollution Control Board.	Undertaking in annexure R4 is enclosed.
5.	State Govt. shall submit an undertaking to comply So Pissued by MoEF & CCOM vide letter No. IA3-22/40/2022-IA.III (E198668) dated 06.02.2023.	Undertaking in annexure R5 is enclosed.
6.	The State Govt. shall rectify and fill the district profile in Part-II, para-14 on the PARIVESH portal.	The necessary correction has been made in the Part-II, para-14 on the PARIVESH portal.
7.	Since the diversion area is falling above the 3000msl, therefore DFO concerned may re-verify the presence of <i>Cedrus deodara</i> in the area, and review the enumeration list accordingly.	Necessary clarification has been attached as annexure R7.





The DFO shall verify the enumeration and accordingly grant felling permission based on the actual requirement. DFO will submit the list of trees to IRO Shimla, granted felling permission by him and trees to be retained.


