12. To commence, file, pursue proceeding for recovery, refund of statutory or any other dues before the State /Central Government and/or competent authorities.
13. To receive and pay, refund amounts so received by us from the statutory authorities, State Government , Central Government and/or any other competent authority as agreed between us.
14. To deal with purchasers of ore from the Said Mine, contractors and other persons and agencies concerned with the working of the Said Mine, with whom we and the Other Heirs have entered into agreements and to represent us with such purchasers, contracts and other persons and agencies in all matters related to the said agreements entered into by us and the Other Heirs with such persons.




