


**Compliance to the EDS in respect of the proposal for diversion of 13.077 Ha. forest land under section-2(ii) of Forest (Conservation) Act, 1980 for construction of approach road from Jumka-Pathiriposhi Pahar Iron Ore Block of M/s Rungta Mines Limited to existing Belkudar-pathmunda\_koira road. (Proposal No. FP/OR/ROAD/154639/2022, State Sl. No.-OR- 035/2022 dated 07.05.2022).**

1	The land schedule of applied diversion area should be authenticated by Range Officer, Koira and Tehsildar, Koira and to be enclosed with the Diversion Proposal.	Enclosed as Annexure-III.
2	The land schedule of non-forest area involved in the project should be authenticated by Range Officer, Koira and Tehsildar, Koira and to be enclosed with the Diversion Proposal.	Enclosed as Annexure-III.
3	As per Letter No. R&DM-GE(GL)-S-63/13-4822/CS dt. 12.02.2015 of the Chief Secretary of Odisha addressed to all Collectors, necessary certificate should be furnished by the Tahasildar as regards status of total land involved in the project (both Forest & Non-forest) as per Govt. record as on 25.10.1980. It has not been furnished.	Enclosed as Annexure-III.
4	In the online application in Para No. L(i), you have mentioned that the non-forest or Revenue Forest land is not required for Compensatory Afforestation. But as per F.C. Guidelines/Rules equivalent non-forest land is required for Compensatory Afforestation, this should be clarified and changed accordingly.	Compensatory afforestation land over 13.077 Ha. has been identified in village Talabarada under Banspal Tahasil, District Keonjhar. Suitability certificate & CA land allotment letter is enclosed as Annexure-IX & Annexure- X respectively.
5	All papers/pages should be signed by the Authorised Signatory of the User Agency.	All papers/pages have been signed by the Authorised Signatory of the User Agency.
6	The applied area delineated in the Topo Sheet (Plate-I/DP) should be authenticated by the Range Officer,	Enclosed as Plate No.-I



9	The layout plan of the proposal for approach road <b>(Annexure-II/DP)</b> should be authenticated by the Range Officer, Koira and Tehsildar, Koira and to be enclosed with the diversion proposal.	Enclosed as Plate No.-V.
10	Plan showing the applied area should be shown in the village sheet and the same shall be authenticated by the Range Officer, Koira and Tehsildar, Koira and to be enclosed with the diversion proposal.	Enclosed as Plate No.-III, IV, IVA, IVB, IVC, IVD & IVE.
11	Undertaking for payment all compensatory levies need to be submitted with the diversion proposal.	Enclosed as Annexure-VIII.
12	Environmental Clearance need to be submitted, if applicable, if not applicable the supporting documents need to be enclosed with the diversion proposal.	As per EIA Notification dated 14.09.2006, the proposed approach road does not pass through any National park/Sanctuaries/ Ecologically Sensitive area. Hence, EC is not required for this project.
13	The Cost Benefit Analysis is to be prepared as per new guidelines issued vide Letter No. 7-69/2011-FC (pt) dt. 1.8.2017 of the MoEF & CC, GoI.	The proposal involves the diversion of 13.077 Ha forest land which is in plain land. As per the guideline issued by MoEF & CC, Government of India vide F. No.7-69/2011-FC(Pt.), dated 01.08.2017, Cost Benefit Analysis is not applicable for this project, as the total area of diversion is less than 20 Ha. in plain land.
14	The proposal should be serially page numbered with Annexure numbering.	All pages of the proposal have been serially numbered & annexed with numbers.
