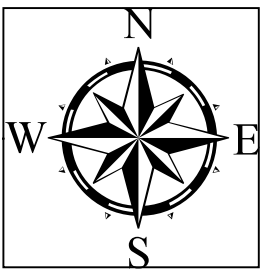


GOOGLE MAP SHOWING THE PROPOSED 27.054 HECTARE AREA OF FOREST LAND FOR WIDENING /

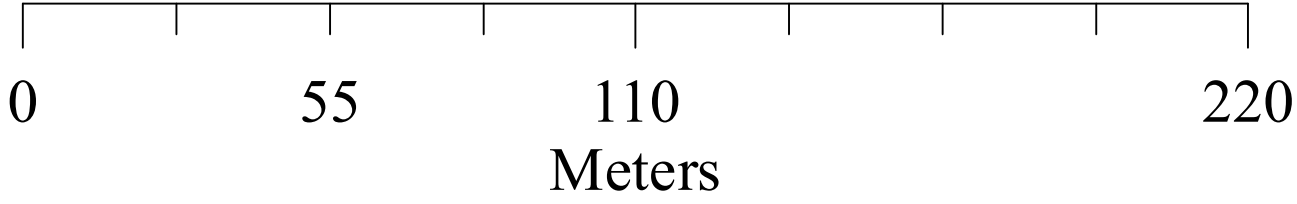

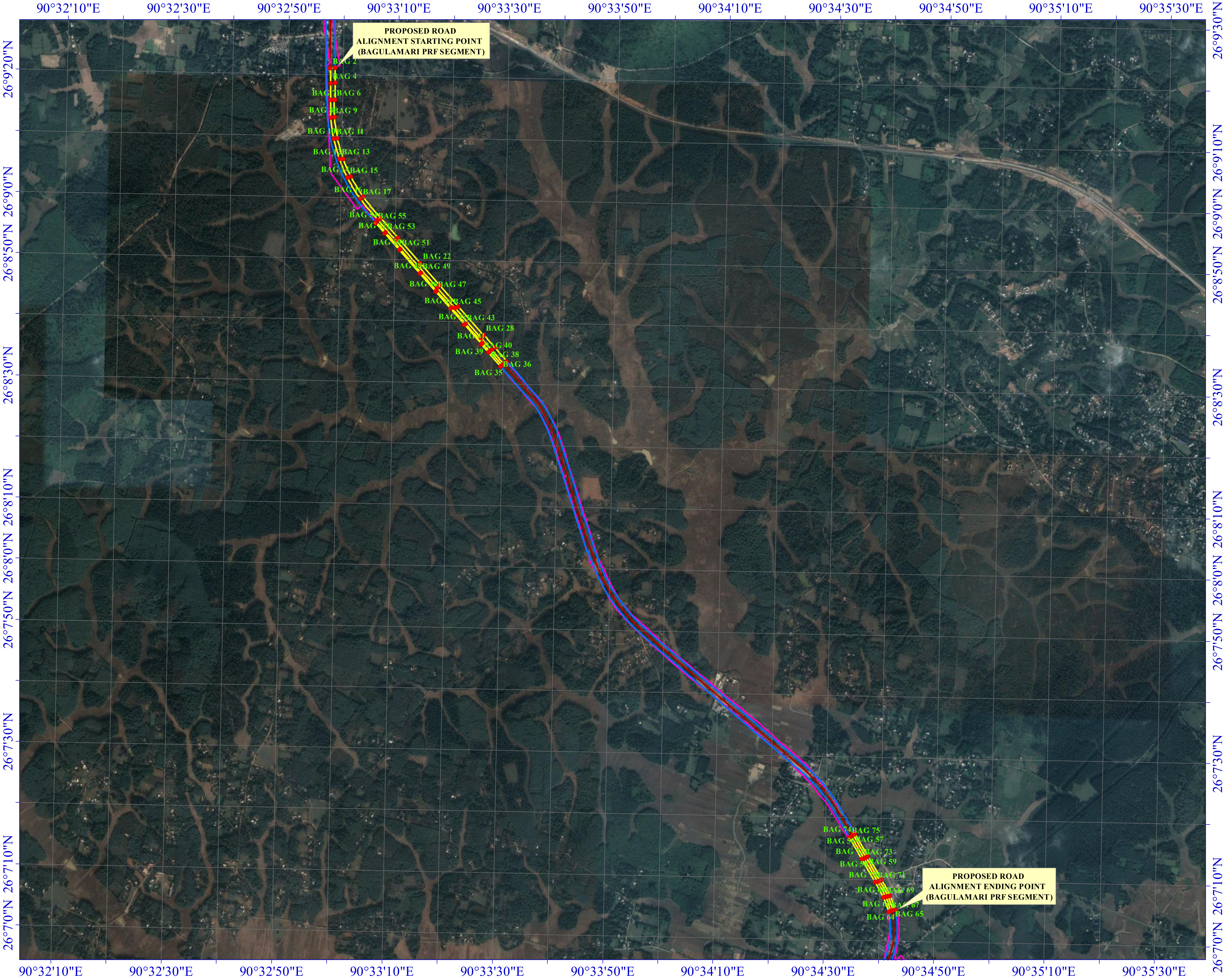

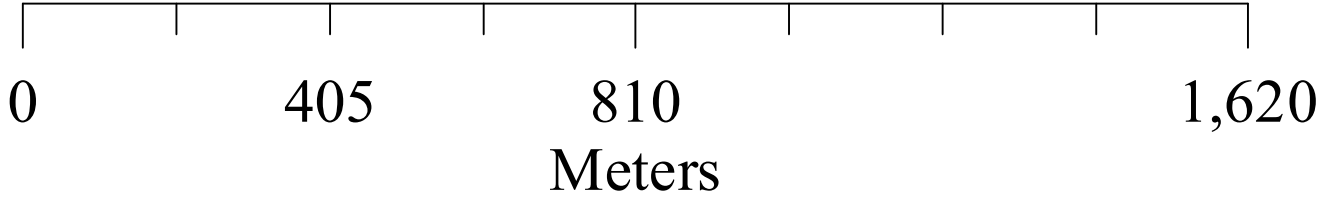

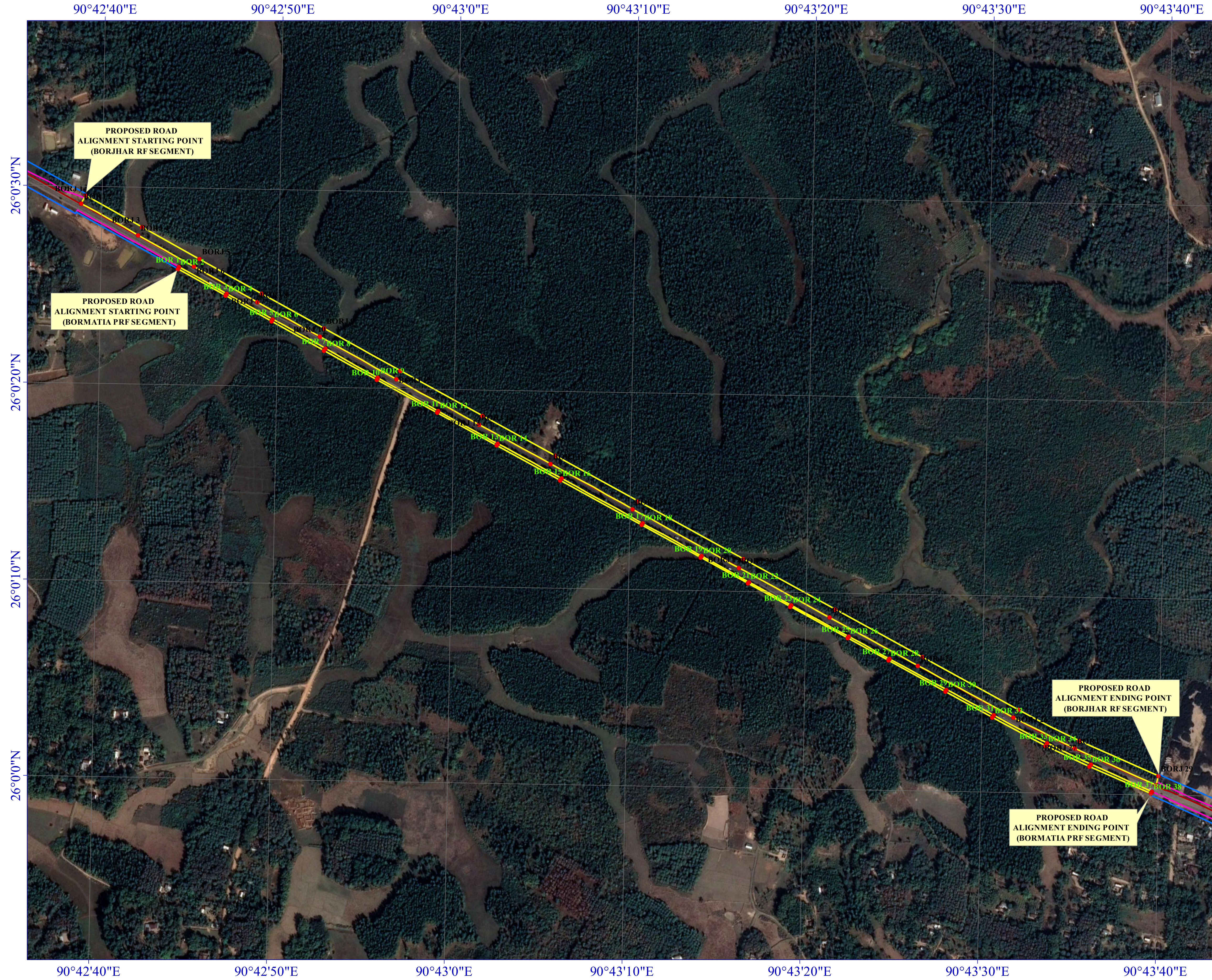

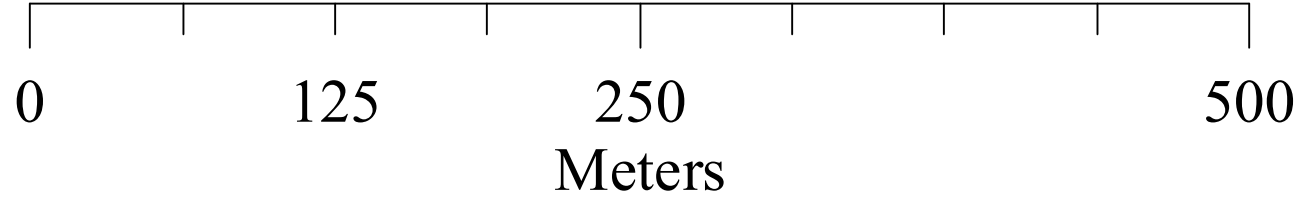

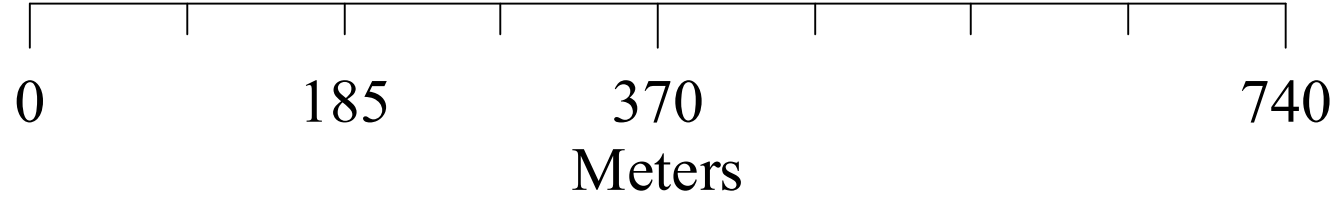

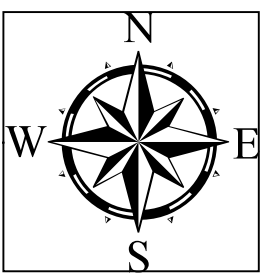

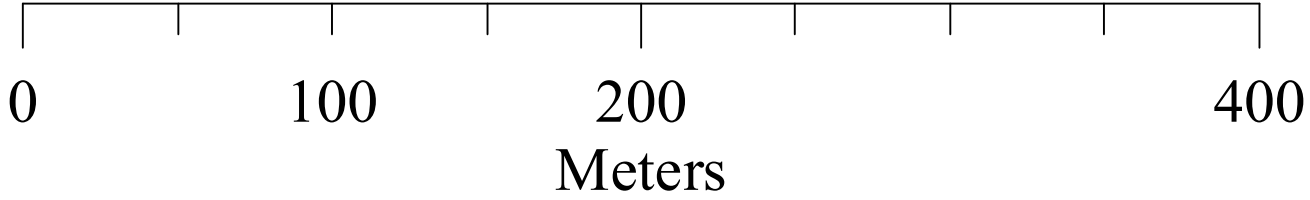

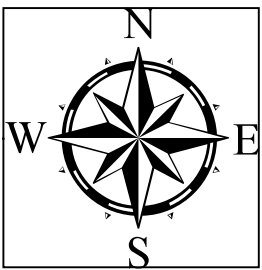

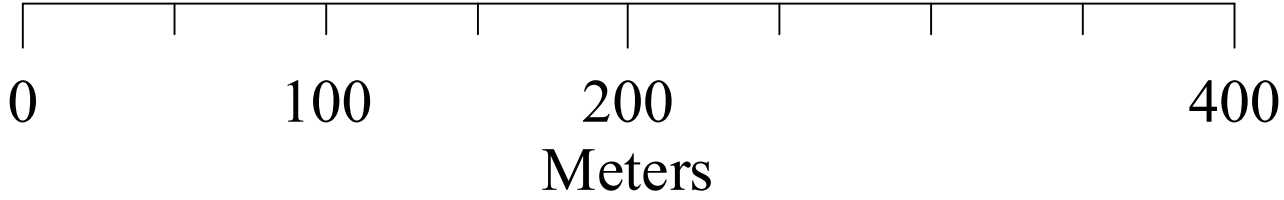
GOOGLE MAP SHOWING THE PROPOSED 27.054 HECTARE AREA OF FOREST LAND FOR WIDENING /
