Specific recommendation of the DCF for acceptance or other wise of the proposal with reason	It is pleasure to recommend the schedule land over 9.533 Ha under Nayabasat Range of Medinipur Division, Paschim Medinipur District to be diverted in favour of Superintending Engineer, N.H Planning & Design Circle, P.W.(Roads) Directorate, Govt. of West Bengal,forConstruction of Twins 2-lane ROB and its approaches in replacement of existing level crossing Gate No. KA-38(Railway Km.165/21-165/23) between Chandrakona Road & Garbeta Stations in Kadamdiha at km 159.448 of NH-60 in the district of Paschim Medinipur of West Bengal. There is no alternative route for the construction of the said ROB. The legal status of the proposed site is protected forest, not vulnerable for soil erosion, does not bear any rate, endangered, unique species of flora and fauna, does not cover any archaeological, heritage site, defense establishment or any other important monument and barest minimum. Undersign has selected 19.066 Ha. (Nineteen Point Zero Six Six Ha.) degraded forest land at Mouza Burisol-677, Mangalbandi- 682, Nepura-686 and Buramara-688underArabariBeatof Arabari Range, Medinipur Division for compensatory afforestation which will enriched green coverage of the Division.
