1.	The state govt. may clarify following regarding the construction of this Adits (a) If this is mandatory structure then why was it not included in the proposal submitted earlier as phase II.	(a) Previously the Adit tunnel was provided in Punad village at a chainage 95.5 km, which was included in proposal (phase II) for which approval of FCA is already granted. During the detailed geological investigation, and site visit of GTI consultants, IIT Roorkee, the site for Adit at Punad was not found suitable for construction on the basis of slope stability and hence rejected. The Adit is an important structure for tunnel construction therefore a suitable site was identified at Jawadi bypass area situated in Rudrprayag-1 of Rudraprayag range, Rudraprayag Forest Division, for which additional land transfer proposal was submitted for FCA approval.
1	(b) state govt. may review the requirement of construction of "Adits" along the alignment already approved and	(b) As per the approved plan Six numbers of the Adits are required for tunnel construction in the entire project which includes the Adit at punad which is being shifted to new location at Jawadi

State govt. may provide details regarding the muck generated in this construction need to be quantified separately and if the provision of dumping is done in the sites selected in previous proposal then details are required to be provided separately viz capacity of site. quantity to be dumped and quantity to be utilize etc	The increase in length of Adit at Jawady bypass will be 230m due to this 14624.55 cu.m additional muck will be generated. As the entire Adit will be constructed through quartzite rock, which is found suitable for aggregate on the basis of Lab.tests, This additional quantity of muck will be used in aggregate for tunnel construction and will not be dumped at nearby dumping sites mentioned in approved Muck Disposal Plan.
