Please find enclosed rectification of discrepancies mentioned in the letter under reference. The rectified documents are resubmitted for processing of the diversion proposal. The point wise rectification is as below:

1. Part-I of Form A in prescribed format.

2. Only pipeline route of the project has been marked in the Toposheet, but the forest area where the pipeline to be passes not marked in the Toposheet. Hence the portion of the slurry pipeline which is coming in Deogarh Forest Division should be shown in the Toposheet in different ink for non-forest land and forest land, and the colour should be indicated in the index to be mentioned in the Toposheet.

**The Portion of the slurry pipeline in non-forest land is marked in dashed line with Magenta (Pink) ink and the forest land is marked in continuous line with blue ink. The colour coding is reflected in the index in each map.**

3. Portion of total area of the present Project which has been applied for Diversion in this Division should be shown in Revenue Map. The forest area and non-forest area should be shown in different colour, and they should be reflected in the index in each map.

**The Portion of the slurry pipeline in non-forest land is marked in dashed line with Black ink and the forest land is marked in continuous line with Green ink. The colour coding is reflected in the index in each map.**

***We undertake that the route of entire pipeline from Barbil to Angul does not pass through National Park or Wildlife sanctuary. Hence, this is not applicable.***
9. Certificate as regards the fact that in case approval under the Act for diversion of the forest land is declined, it is technically feasible to execute the project along an alternate alignment without involving diversion of forest land.

10. Undertaking as regards execution of work on non-forest land shall not be cited a reason for grant of approval under the Act and incase approval under the Act for diversion of forest land is declined, width of the portion of road falling in the forest land will be maintained at its existing level.  
***The work in non-forest is not yet started and it will only start once we obtain Forest Diversion clearance from Forest department. An undertaking for the same is enclosed.***
11. Undertaking as regards the instant proposal is processed in their entirety covering all Divisions/Districts/States.
