
With reference to the above, I have the honour to furnish the Essential Details Sought through under reference for the application of forest land diversion proposal. The details are:

1.	A-1-(iii) - The forest area to be diverted is not mentioned in the Short narrative of the proposal and Project/scheme for which the forest land is required. Please rectify the mistake.	A-1-(iii) – The Short narrative has been revised and the forest area to be diverted is mentioned.
2.	C – (ii) - After examination of the uploaded KML file it is revealed that the area encompassing is 43.502 ha whereas the proposed forest area for diversion mentioned in the Form- A Part-I is 43.47 ha. So, rectify the disparity.	C – (ii) – The area of the forest land to be diverted is 43.47 ha, it is calculated using ArcGIS whereas the area was found to be 43.502 ha when it is calculated using QGIS. The matter was discussed with officials of the Nodal Officer, FC Act, 1980. During examination, 43.47 ha was found to be correct.
3.	C – (iii) - The title of the proposal is not given in the header section of the uploaded 1:50,000 SOI toposheet. Please rectify and upload the same.	C – (iii) – The title of the proposal has been mentioned in the header section of the map and uploaded.
4.	C – (iv) - The uploaded layout map is not acceptable. Please upload the Geo-referenced toposheet with proper heading, labels and legends.	C – (iv) – A Geo-referenced toposheet map with proper heading, labels, and legends is uploaded.
