The road will connect Upper Polok to Upper Borong Village (which is approximately 20.5 km from Rabong towards the north direction) the proposed road is 3-km. Presently there are no any means of transportation facilities to this village so as to connect with the District Namchi & other important towns of South district. The majority of population are farmers and solely depend on the agricultural products. The road on completion will act as the lifeline of the people of the area for transportation of their agricultural products to the town & help to transport their basic household amenities. It will also help them to reach the District offices, centre/facilities provided by the Government.
