
Kindly refer to the observations raised by Regional Officer, Integrated Regional Office, Ministry of Environment, Forest and Climate Change, CGO Complex, Shivalik Khand, Longwood, Shimla, Himachal Pradesh – 171001 vide letter No. F.C./H.P.B/09/43/2021 dated 12.12.2021 on the subject cited above. In this regard we hereby submit our point wise reply against the observations as under:

1. The Open Area within Boundary area 0.0197 ha is the back end area within boundary which will be used to create green lungs. This area will be used to dump the muck and level the area. Later trees will be planted in this area to create green lungs.
2. The FRA Certificate is under process and will be submitted before seeking final approval for diversion of 0.4047 ha of forest land for construction of Septage Treatment Plant Sakoh at Dharamshala. An Undertaking in this regard is enclosed herewith in quadruplicate.
3. The Open Area within Boundary is the back end area within boundary which will be used to dispose off the muck and level the area and later this area will be used to create green lungs in the area by planting trees and create green cover in the area.
4. The Alternative sites have been depicted in the KML file and uploaded online.

5. The Septage Treatment Plant Sakoh at Dharamshala is proposed alongside and is connected with road from North and North-West corners, so no approach road has been proposed.
6. The point pertains to your office.
7. The Layout of the Proposal has been uploaded online and same is enclosed herewith in quadruplicate.
8. The Beneficiary villages have been marked on the KML file.
9. The NOC from the HP State Pollution Control Board has been uploaded against Additional Information Details and copy of same is enclosed herewith in quadruplicate.
10. The NOC from Local Panchayat has been uploaded against Additional Information Details and copy of same is enclosed herewith in quadruplicate.
11. The Administrative Approval Letter has been uploaded online against Additional Information Details and copy of same is enclosed herewith in quadruplicate.

Therefore we request you to kindly reconsider our proposal for diversion of 0.4047 Ha. forest land for the construction of the above cited Project.
