

In compliance of the Rule 6(3) (e) of the Forest (Conservation) Rules, 2003 [as amended vide the Forest (Conservation) Amendment Rules 2014; Forest (Conservation) second Amendment Rules 2014; and Forest (Conservation) Amendment Rules 2016] it is certified that 6.17 Hectares of forest land proposed to be diverted in favour of **PMGSY Division Marwah** for **construction of road Ikhala Block Boundary Kishtwar to Lopara Part-II Km 54<sup>th</sup> to 67<sup>th</sup> Pkg no. JK04-167** in the district falls within the jurisdiction of **Forest Division Marwah** village **Lopara and Hanzal (Panchayats Lopara and Dherna) respectively** in **Dachhan** and **Marwah** Tehsil, It is further certified that:

- (a) The complete process of recognition and vesting of forest rights under the FRA has been carried out for the entire 6.17 hectares of forest land proposed for diversion. The proposed area does not cover any part of the FRA-2006, since there is no any claim in this area as on date. - (c) The proposed area does not involve recognized rights of Primitive Tribal Groups and Pre Agricultural Communities: report in this regard from Executive Engineer PMGSY Div Marwah along with recommendation / report of Gram Sabha Resolution ( duly signed by FRC committee members) is enclosed as **Annexure "A"**


