

With reference to the above letter, the Permission is granted as per below mentioned terms and conditions in respect of assess to Road is granted as per recommendation of Sub Division Engineer, Construction Sub Division No.4, PWD B&R Patiala:-

1. The company/Petrol Pump Franchise shall be bound to compliance with all the directions prescribed by the Government, as per fresh notification dated:24-1-2019 for retail outlet.
2. The company/Petrol Pump shall be bound to comply with the directions/conditions of IRC/PWD/Puda as amended from time to time.
3. The company shall be bound to make all the necessary construction with service road at its own expenses as per enclosed drawing for petrol pump 9.00 Mtr. of 2 Number Entry and exists and both side 5.50 Mtr. (18 Feet) wide 70 Mtr. and 100 Mtr. in length (De-Acceleration lane and Acceleration lane).
4. The company/Petrol Pump Franchise will make this sure that the water of petrol pump premises may not flow towards road or burm.
5. The company/Petrol Pump Franchise will make the structure construction as per enclosed approved drawing and will start supply of oil on pump only after availing the completion certificate from this office within 6-12 months.
6. The company/petrol pump franchise, as and where if there would be in sufficient ROW space of department service

- road (De-Acceleration lane and Acceleration lane) and Turing Radius and which the additional space shall be required then the company/franchise shall be bound to level and to acquire the additional premises for this purpose at its own costs.
7. The company/Petrol Pump Franchise will make any temporary or permanent construction leaving away 30m+5m for NGT Mtr. 35 Meters from the jurisdiction of Public works Department.
 8. The company/Petrol Pump Franchise will make the buffer strip construction outside jurisdiction of Public works Department.
 9. The company/Petrol Pump Franchise will not stock any material on the road or burms during the construction work of petrol pump.
 10. The company/Petrol Pump Franchise will mark the demarcation for petrol pump premises in the presence of Sub Divisional Engineer/Junior Engineer (PWD).
 11. The plinth level of the pump will remain below 2.50% (300mm) from the level of road by the company/Petrol Pump Franchise.
 12. The company/Petrol Pump Franchise shall be bound to bear all the expenses it self for the slab type, culvert as per IRC:SP-13 and construction of Drain as per site plan and after completing this, the company shall also be responsible for look after (maintains) at its own responsibility.
 13. If the company would require any service road then the expenses of construction and maintenance which will be spent, the company will deposit the same with this department.
 14. At present or in future as and when, the land which will be required by the Government for Improvement/Widening, 4/6 lining of road then the construction earlier made either temporarily or permanently shall be the responsibility to demolish the same at the cost of company and the company (franchise) will not claim any charges in this respect.
 15. The owner/authorized signatory shall be responsible himself to avail separate permission regarding this assess to road case, if required to be availed from any other departments like Pollution Control Board, Forest Department etc.
 16. The company/Franchise shall be bound to make the construction of sock pit/recharge pit as per specifications.
