In the above subject and reference, the reply to the observations as raised by the GoI, IRO, MoEF&CC vide his letter under reference is given as under: -

Regarding the Cumulative Impact Assessment & Carrying Capacity (CIA&CC) study the Chief Engineer (Energy), DOE, Govt of HP, Shimla in his letter No. HPDOE/CE(Energy)/Himurja/2022-9997-98 dated 6.03.2023 issued to Nodal Officer (FCA) HP, Shimla. Since the CIA studies in Ravi Basin have not been carried out as such as and when the studies are carried out the project already allotted by the Govt. shall be required to be considered as per their allotted domains. Therefore, it shall be appropriate that the domains already allotted in this project may be considered for grant of diversion"

The DOE has also added in his letter that in the year 2015, MoEF&CC, GoI took inprinciple decision that henceforth all the CEIA & CCA study in all River basins will be conducted by MoEF&CC, GoI itself. Accordingly all the studies undergoing in the State of Himachal Pradesh were handed over to MoEF&CC, GoI. As such the mandate of such study is now with GoI, MOEF &CC. (The letter of DOE referred above is enclosed herewith).

Besides, above Chief Executive Engineer, HIMURJA vide his letter NO.10322 dated 22.02.2023 has clarified the procedure of allotment of small hydro projects with respect to size capacity and all other aspects. (Copy enclosed herewith).

From the above, it is very clear, that project allotment is made as per the Hydro Policy provision of Govt. of HP and the criteria laid down in the policy after conducting all detailed study, approval of DPR and Technical Concurrence from the DOE. Therefore, your self is requested to kindly take up the matter the competent authority for obtaining the stage-I approval under FCA-1980.

Since, the CIA studies in Ravi Basin have not been carried out as such as & when the studies are carried out the project already allotted by the Govt. shall be required to be considered as per their allotted domains. Therefore, it shall be appropriate that the domains already allotted in this project may be considered for grant of diversion of 0.9854 ha., of Forest land in favor of M/s Banni Hydro Projects.

It is further intimated that in the year 2015, Ministry of Environment and Forest (MoEF), CC, GoI took in- principle decision that henceforth all the CEIA and CCS study in all River basins will be conducted by MoEF, CC, GoI itself. Accordingly, all the studies undergoing in the State of Himachal Pradesh were handed overt to MoEF, CC, GoI. Further it is also apprised that TEC of Project was accorded vide letter no. 3408-17 dated 04.08.2021 (Annexure-B).

In this context, it is amply clear that the mandate of such study is now with MoEF, CC, GoI, hence the matter may be taken up accordingly and diversion 0.9854 ha., of forest land in favour of M/s Banni Hydro Projects may be granted.
