With reference to the subject and reference cited above, we are submitting five set of proposal with due correction, which are follows.

1	The copy of online application for approval under section 2(ii) of FC Act 1980 has been enclosed with the diversion proposal, but the said application is under section 2 of the FC Act. Hence the online Part (i) of Form A need to be enclosed with the diversion proposal.	The online Part (i) of Form A is corrected and enclosed with the diversion proposal.
2	All Check list number has not provided in the diversion proposal and to be enclosed with the diversion proposal.	The checklist number has been corrected and attached in the Diversion Proposal.
3	Compensatory Afforestation Scheme has not enclosed with diversion proposal and to be enclosed with diversion proposal along with all maps.	The CA Scheme over a land of 110.813 Ha in the village Jhunmur and Jaidega of Biramitrapur Range office and Kuanrmunda Range Office respectively and enclosed with the proposal along with all maps as Annexure 24.

4	As per Letter No.R&DM-GE (GL)-S-63/13-4822/CS dt.12 .02.2015 of the Chief secretary of Odisha addressed to all Collectors, necessary Certificate should be furnished by the Tahasildar as regards status of total land involved in the project (both Forest & Non-forest) as per Govt. record as on 25 .10.1980 . The same has not enclosed with the diversion proposal.	The status of Total included in the project (both Forest and Non-forest) as per Govt Record as on 25/10/1980 has been attached as Annexure 4 with the proposal.
5	In the Plan showing the proposed Land Use (Annexure-22), it has mentioned one Nalla and Road passes through the Block area. Hence, 50 mtr either side of Nalla and 10 mtr either side Road shall be protected and the area should be mentioned in the table of the Map and the same to be authenticated by Range Officer, Koida and Tehsildar, Koida & DOM, Koida and to be enclosed with the diversion proposal. Further, necessary correction to be made all the Maps where the Nalla and Road has been shown and the same shall be authenticated by the DOM, Koida, Tehsildar, Koida and Range Officer, Koida and enclosed with the diversion proposal.	In the Map Protected area of 50 m on either side of the Nalla and 10 meter on either side of the road has been duly marked and authenticated from the office of Tehsildar, Range Officer and DDM Koida. The same is enclosed with the proposal as Plate No 6.
6	Land schedule of the safety zone area and green belt area enclosed in the diversion proposal need to be authenticated from DDM Koida, Tehsildar Koida and Range Officer Koida and enclosed in the diversion proposal.	The Land Schedule of Safety Zone and Green Belt area is duly authenticated from the Tehsildar, Range Officer and DDM Koida and enclosed with the proposal as Annexure 19, Annexure 20.
7	Undertaking to the effect that the applicant shall deposit compensatory Levies i.e. SSWLCP, RWMP etc to be enclosed with the diversion proposal and undertaking for pending court cases. Also enclosed with the diversion proposal. However, the same has not followed.	Undertaking from the applicant to deposit the compensatory levies such as SSWLP and RWMP is prepared and attached herewith as Annexure 10.
8	The list of tree enumeration in the Non-Forest Land is not matching with the abstract. The Same should be corrected, both field and paper and the same should be enclosed with the diversion proposal after duly authenticated from the Range Office Koida and the revenue authority.	The list of Tree enumeration in the non-forest land has been corrected and duly authenticated by Range Officer Koida and Revenue Authority – Tehsildar Koida as Annexure 7.
9	Cost of the project mentioned in the online application as 5000L, but the same has been	The cost of the project is 205 Crore, which is checked and

	mentioned in the Offline part 1 as 760 Crore. This may be clarified and checked accordingly.	corrected.
10	Blank forms i.e. Form No II, III, IV and V to be enclosed with the diversion proposal.	Blank form – Form II, III, IV and V is enclosed herewith the diversion proposal in Page No 20,21,22,23.
11	No objection certificate shall be obtained from the Collector Sundargarh under the Forest Right Act 2006 and enclosed within the proposal.	As the code of conduct for Panchayat Election was imposed, Collector Sungargarh has advised to conduct FRA related activities post-election. Therefore, we undertake to conduct the FRA post-election.

Therefore, we request you to kindly consider our proposal for diversion and advice for future course of action.
