# MINUTES OF THE FORTNIGHTLY REGIONAL COORDINATION MEETING HELD ON 30th OCTOBER, 2023

The Fortnightly Regional Coordination Meeting (FRCM) was held on 30<sup>th</sup>October 2023 at 11:00 AM in the conference room of the Regional Office, MoEF&CC, Dehradun under the Chairpersonship of Shri. Gobind Sagar Bhardwaj, IFS, DDG, MoEF&CC, Regional Office, Dehradun to discuss the pending proposals.

At the outset, APCCF, RO, MoEFCC, Dehradun welcomed all for the meeting and following proposals which were identified by the RO were discussed in the meeting.

Agenda Item No. 01:Diversion of 3.255 ha of forest land for the construction of Diuli Gijrada Motor Road under State Sector in VidhansabhaNarengra Nagar, in favour of Public Works Department (PWD), within the jurisdiction of Narengra Nagar Forest Division, Munikireti in Distt. Tehri Garhwal, Uttarakhand. (FP/UK/ROAD/155324/2022)

The proposal was discussed in detail with the concerned project proponent in the meeting. The KML file of the proposed road was seen in the meeting and it was noticed that the proposal aims to connect villages Kaljoti and Kharki. The proposed road will provide connectivity to village Kaljoti which is still not connected to any road. Further, the proposed road will shorten the distance of village Kharki and other villages lies at the end

point of proposed road to Block Headquarter Narendernagar.

After detailed discussion, it was decided to accord in-principle approval for diversion of forest land.

Agenda Item No. 02:Diversion of 0.35 ha of forest land for construction of Banwaldhar Jarmwar to BainjiKandai Motor Road in favour of PWD, within the jurisdiction of Rudraprayag Forest Division, District Rudraprayag, Uttarakhand. (FP/UK/ROAD/155241/2022)

The proposal was discussed with the DFO concerned and project proponent in the meeting. The KML file of the proposed road was seen in the meeting. It was noted that villages Jaramwar and BainjiKandai are already connected with existing road. This office earlier raised an observation in this regard, to which it has been submitted that due to landslides in the existing road, the road is mostly obstructed the existing road is not in much use. The user agency stated that in the proposal maximum area is non-forest land and only a small patch of forest land is covered under the proposal. Further, from the KML file, it was seen that there is a steep slope of around 55-60 in the starting point of forest patch of the road which appear vulnerable to erosion and may lead to rolling down of muck. It was also asked as to why the road is not proposed on the ridge avoiding the forest area, to which the user agency seem unprepared.

After detailed discussion, it was decided that the DFO may visit the site along with the local engineer and geologist. They may reexamine that steep slope and explore alternate to avoid steep forest area which is above to proposed alignment.

Agenda Item No. 03:Diversion of 2.49875 ha forest land for construction of Chitai Pant-HaridattPetshali Inter college motor road till Petshal in favour of PWD, within the jurisdiction of Almora Forest Division, District Almora, Uttarakhand. (FP/UK/ROAD/9220/2015)

It was noted that Stage-I approval has already been granted in the proposal vide letter dt. 17.11.2020. Later to which it was seen that the User Agency has changed the alignment of road without the necessary permission of the Central Government. The observation in the case were communicated to the State Govt vide letter dt. 04.10.2023 and it was asked to prepare reply and represent the case in FRCM. But, neither DFO, Almora Forest Division nor the Project Proponent were present in the meeting to represent the case. Hence, the proposal was not discussed. It was apprised that the case is under consideration of Hon'ble

NGT and hearing is to be taken place in November,2023 therefore is a serious matter. But it appeared that DFO and Project Proponent are not interested in the proposal and are not understanding the seriousness of the matter.

After the discussion, it was decided to issue a DO letter to PCCF regarding the absence of the DFO and Project Proponent to represent the proposal which is under consideration in Hon'ble NGT.

Agenda Item No. 04: Diversion of 26.08 ha of forest land for the relocation of Hon'ble High Court Establishment from Nainital to GaulaparHaldwani, District Nainital in favour of Public Works Department, within the jurisdiction of Tarai East Forest Division, Haldwani, Distt. Nainital, Uttarakhand. (FP/UK/OTHERS/435756/2023)

The proposal was discussed in detail with the Project Proponent and the concerned DFO. The KML file of the diversion area was seen in the meeting. It was noted that observation on few points was raised by this office in the proposal, reply to which is awaited. A point wise discussion on the observations was held in the meeting with the team of Project Proponent headed by Principal Secretary, Law. Regarding the justification of the area requirement, it was informed by the project proponent that initially 41 hectares of area was proposed for this purpose after which it was discussed in the Hon'ble Supreme Court and a full forum decision was taken to acquire only 26.08 hectares of forest land which is bare minimum according to strength of judges and requirement for proposed construction. It was also informed that total built up area is only 40% of the area proposed.

Regarding the residential area, it was informed by the project proponent that it is an integrated court complex in which intact residential of complex is mandatory for security point of view. Regarding the single storied building, it was informed that except for the residence of the Chief justice all the building will be multi-storied.

The DFO informed that around 6.6 ha area is proposed for residential complex as a separate patch and was previously diverted for the construction of ISBT, Haldwani. Later on the case was withdrawn by the State and the area was surrendered to the Forest Department. The DFO also informed that the site was inspected and is found site specific as no other available land found suitable for the purpose for the relocation of High Court campus. The DDG, Regional Office Dehradun examined the above mentioned fact and highlighted the mandatory documents/clarification prior discussing the case before Regional Empowered Committee Meeting.

After detailed discussion, it was decided that the State Government is required to submit clarifications/documents on following points:

- The technical brief of all discussions held in between various departments/authorities with the Hon'ble High Court on assessment of the area required for relocation of the High Court complex from Nainital to adjoining to Gaula River. There should be mentioned in the statement that the requirement has been kept to the barest minimum. Further the details of the norms/guideline/rules may also be mentioned under which the requirement of area has been assessed.
- The detailed conceptual layout showing all components along with area and dimensions of the components for the proposed work may ask to submit.
- The revised cost benefit analysis in prescribed format may ask to submit.
- 4. The State Govt may ask to review the requirement of residential complex once again and try to reduce the requirement not more than one hectare in forest area. The detailed justification for establishing its inescapability for locating the residential complex in forest area.
- 5. The enumeration may be asked to be reviewed in view of the layout and try to assess the setback areas that are not under construction and trees can be saved of the areas. Accordingly indicate the number/percentage of trees that can be saved.

Agenda Item No. 05: Diversion of 3.9 ha of forest land for construction of LokhandiBudherVan Marg to Village Udawa Motor Road in favour of Public Works Department, within the jurisdiction of Chakrata Forest Division, Distt. Dehradun, Uttarakhand. (FP/UK/ROAD/48173/2020)

The proposal was discussed with the DFO concerned. The user agency was not present during the meeting. It was noted that the proposal was discussed in the FRCM meeting held on 24.01.2023 wherein it was directed to propose the road in 3-4 mtr width as the maximum alignment is going through reserve forest land and as the proposed road is connecting an isolated village where volume of traffic is expected to be very low. After which the State Govt submitted the reply that the proposal cannot be considered for width of road less than 9 meters.

It was seen from the KML file that as the proposed road is connecting an isolated village so the proposed width of 9 meter in reserve forest area cannot be accepted. Further, the DFO informed that there is a forest guest house also and the width of the same is 3-4 meter. So, the proposed road going further to forest road in 9 meter width is not justifiable.

After the detailed discussion, it was decided that DFO will visit the area again and will submit the revise documents with bare minimum width to save the reserve forest land as it is to connect an isolated village wherein the traffic volume will be very less in the area. Revise land schedule, CA documents, NPV sheet, tree enumeration list etc. will be uploaded in this proposal only replacing old area documents.

The meeting ended with a vote of thanks.
