Shri. Sandeep Suresh Dapke, authorized signatory of Shri. This proposal is for construction of bunglows and residential buildings in restored private forest land. The order of restoration is of 23rd July 1985, subsequently permission for

restoration from Government of India has been received in 7th July, 1995. This project involves 9.78 ha of land, but as it is in restored private forest land, the User Agency is not ready to give compensatory non-forest land for compensatory afforestation. But the User Agency is ready to give all Government levies, and also ready to give equivalent non-forest land to the extent of diversion of forest land if Government of India insists. The project authority is willing to bear the cost of compensatory afforestation as required by the Government.

This proposal is for construction of bunglows and residential buildings and other ancillary activities in restored private forest land and the Project proponent is ready to bear all the Government levies hence the proposal is being recommended for approval for diverting the required forest land under Forest (Conservation) Act, 1980 on the following conditions-

1) The legal status of forest land shall remain unchanged.

2) The area diverted will be used only for the purpose mentioned in proposal.

3) Cost of compensatory afforestation to be borne by the Project Authority.

4) Net Present Value to be borne by Project Authority.
