



Site Inspection Note

Sub :- The Project Site for Retail Outlet of M/S BPCL located at Khata No – 306, Plot No- 4935, Thana No – 584, Thana & Anchal – Fatehpur, Distt- Gaya on SH – 70 Rajauli – Wajirganj road was inspected on 19.05.2022. The Petrol pump applicant/ representatives of the user agency were present during the time of inspection.

The instant project site proposed for diversion of forest land (linear) for making entry and exit passage to Fuel Pump of BPCL by the applicant dealer Shri Anand Kumar, S/O Shri Bijay Saw, Village – Chapri, PS – Fatehpur, PO – Charokhari, Dist - Gaya. The important point of site inspection report are :-

1. The proposed project requires land for entry and exit of vehicles for the proposed BPCL retail outlet, which has to pass through the linear Protected Forest along the SH – 70 Rajauli – Wajirganj road, which was notified as Protected Forestvide Department of Environment, Forest and Climate Change, Government of Bihar's notification no. S.O- 400 dated- 31.12.1996.
2. The Forest area required for the project is 0.01762 Ha. The proposed site is barest minimum required for the proposed project.
3. Some trees were found in the proposed pathway (Palm – 3, Sisham -1) were found which needs to be removed/translocated. The Sisham tree has to be translocated as per Tree protection plan for which proposal is required after FC clearance.
4. Apart from the above mentioned point, the undersigned concurs with the rest of the report and recommendation of the concerned Deputy Conservator of Forest, Gaya Forest Division, Gaya.
5. The proposal may be sanctioned subject to the condition of payment of amount for NPV and compensatory afforestation by the User Agency.
