A Proposal has been received by this office from Executive Engineer Construction Division - I PWD Muzaffarnagar for Widening and Strengthening of Muzaffarnagar - Jansath Road (End Point Bhopa Flyover) Bothside KM CHAINAGE 2.290 to Km Chainage 5.000 in VILLAGE Almashpur , Sahawli, Bibipur Tehsil Sadar in Muzaffarnagar Forest Division Uttar Pradesh under (FCA-1980) of 1.8970 ha. of Protected forest land for non-forestry purpose. The Project envisages the use of forest land for Widening and Strengthening of Muzaffarnagar - Jansath Road (End Point Bhopa Flyover) in village Almashpur , Sahawli, Bibipur Tehsil-Muzaffarnagar in Disst. Muzaffarnagar.
