Attention of the President, Mudimiyal Kancha Farmers and Farm House Association, Mudimiyal Chevella RR District is invited to the references cited.

The proposal for diversion of 0.20 Ha of forest land for the subject project as submitted by the President, Mudimiyal Kancha, Farmers & Farm-Houses Association Mudimiyal, Chevella, Rangareddy District, TS, Hyderabad in the reference 1st cited has been forwarded to the field officers vide ref (conservation) Act, 1980 and amendments issued thereof.

The Chief Conservator of Forests, Ranagareddy Circle in the ref 3rd cited has submitted processed proposal and has recommended for rejecting the proposal in Part-III, based on the recommendations of the Forest Divisional Officer, Shamshabad & District Forest Officer, Rangareddy in Part-II, on the following grounds:

- Forest area proposed for diversion is avoidable as alternate routes is available to reach the farm lands in question avoiding the forest area.
- The Reserve Forest Block in which diversion is proposed is already badly fragmented into (8) bits due to existing roads and allowing any new roads will further fragment the area & would adversely impact the bio-diversity and wildlife of the area and in addition will increase biotic interference.

 Assuming that the farms land belong to Agency can access all the farm lands through the roads already being used by all the villagers to reach their agriculture lands.

In view of the above, the Director, President, Mudimiyal Kancha, Farmers & Farm-Houses Association Mudimiyal, Chevella, Rangareddy District, TS, Hyderabad is informed that the proposals for diversion 0.20 Ha of forest land for the subject project in Shamshabad is **not agreed to**.
