Do not agree with the scheme of CA proposed by DCF Bhiwani for this project.

The U/A has originally applied for diversion of 0.081 Ha. forest area (Proposal detailed No. FP/HR/Approach/48019/2020) for Which final approval has been conveyed vide letter No. 9544/1051 dt. 15.03.2021. In the said proposal, 20 trees and 42 saplings were affected in addition to diversion of 0.081 Ha. forest area for which the following CA Scheme was prepared:-

- 1. CA in lieu of 20 trees to be filled (for 200 plants)-292816.00
- 2. AdditionalCompensatory Afforestation-122988.00
- 3. Net Present Value 71847.00
- 4. Soil Mositure Conservation Charges 96629.00
- 5. Supervisory Charges 29282.00
- 6. Felling Charge 20112.00 **Total Amount -633674.00**

During the site inspection it was found that the U/A intends to divert additional 0.0019 Ha. area for construction of open drain in the 'D' area for which one tree also will be filled. The U/A has already violated the provisions and constructed part of the drain in 'D' area for which suitable action has been taken by DCF Bhiwani.

Since the additional land intended to be diverted is part of the same project under proposal No.

FP/HR/Approach/48019/2020 for which CA Scheme was already prepared, now the following charges only are required to be recovered from the U/A on account of CA.
