
3. Specific recommendations concerned Chief Conservator of Forest for acceptance or otherwise of the proposal with detailed reasons.

Specific Recommendations of CCF, Bharatpur.

The proposed site falls in the forest land of Kota A Forest Block in Karauli Range and Karauli Division and the proposed road will divide the area into two parts. The project is going to affect the area by the way of change in land use and fragmentation of the forest land.


The site specific conditions and measures are recommended to be carried out to mitigate the effect of the proposed activities as follows:

1. The User Agency shall have to give speed breaker at appropriate distances and put proper signages on the sides to avoid entering to the forest land and do not disturb the wildlife in the along the road.
2. Permanent demarcation of the road area by erecting proper stone marks along the alignment before starting the project by the UA on the project cost.
3. No labor camps shall be established in forest land.
4. Working time is to be followed from sun rise to sun set.
5. If any blasting of rocks involved, the UA ensure only after the presence of local field staff to avoid any killing of wild animals nearby areas of the forest land
6. The road proposed in the forest area is to be laid out inside forest block without any major damage to the forest land and dump the waste along the forest land.
7. Both side avenue plantation with individual tree guards shall be created in the proposed project. Underpasses may be provided in appropriate places to give the space for animal movement from one side to other.
8. UA shall provide proper drainages along the road and culverts across the roads to prevent the soil erosion after the project.
9. UA shall use the land for the diverted purpose only and shall not give this land to any other department for any other purposes.

10. UA shall comply all the conditions of the diversion of forest land and submit the completion of work in the stipulated time period.

The proposal is expected to help the local people connectivity to the main road and also help Forest Staffs to move for their regular patrolling of the forest areas nearby. The impact on the wildlife and forest fragmentation and wild animals' movements will be reduced in the proposed diversion by the above prescribed conditions. Hence, it is recommended for approval under Forest Conservation Act, 1980.
