- 1. The Superintending Engineer (Civil), Ministry of Road Transport and Highways (Government of India), Regional Office, Race Course Road, Bengaluru[USER **AGENCY**] vide Ref (1) has submitted an online proposal [FORM-A PART-I] through FC web portal seeking approval under Section 2 of the Forest (Conservation) Act, 1980 for Diversion of 2.5254 hectare of forest land in Kenkere Sy. No 278 Chiknayakanahalli Taluk, Tumkuru District for Reconstruction of twolane Road with paved shoulders from Ds. Ch. 442+180 (Ex. Km 448.00) to Ds. Ch. 485+240 (Ex. Km 494.000) of Huliyar to K.B Cross Section and from Km Ds. 532+100 (Ex. Km 533.150) to Ds. Ch. 539+100 (Ex. Km 540.175) from KB Cross to Nelligere section of NH-150A. After uploading of Acknowledgement on 21-02-2022 by User Agency for having delivered the hard copies of the proposal to jurisdictional Deputy Conservator of Forests and Deputy Commissioner, an online communication was made by the Nodal Officer (FCA) vide Ref (2) to the Deputy Conservator of Forests (s), Chitradurga and Tumkuru Divisions to process the proposal under the Forest (Conservation) Act, 1980 and to submit specific opinion / recommendation.
- 2. Location details and Component-wise breakup of forest land requirement: The details of the location of forest land and component wise requirement are given below.

- **3.** Report of DCF, Chitradurga Division: The Deputy Conservator of Forests, Chitradurga Division has inspected the site on 29-08-2022, 09-09-2022 and vide Ref (3) has submitted his report along with Site Inspection Report in PART-II to Chief Conservator of Forests, Ballari Circle. Main features of the proposal based on the reports of the Deputy Conservator of Forests, Chitradurga Division r/w report of Chief Conservator of Forests, Ballari Circle and that of ICT Centre of Forest Department are summarized below.
 - a. The forest area proposed for diversion is not vulnerable to soil erosion.
 - **b.** The forest land proposed for diversion is in general landscape of Eco-class-III (Tropical thorn Forest) with a Canopy Density of up to 0.1 (Open Forest).
 - c. As per Item 4(ii) of PART-II of the proposal, there are no trees on the forest land proposed for diversion.

- **d.** Main wild animals reported in and around the project area include Sloth bear, Leopard, Wild Boar, Hare etc.
- **e.** There are no other rare / endangered / unique species of flora and fauna reported in and around the forest land proposed for diversion.
- f. The forest land proposed for diversion does not form part of any National Park/ Wildlife Sanctuary/ Biosphere Reserve/ Tiger Reserve/ Elephant Corridor/ Wildlife Migration Corridor, etc.
- **g.** There are no Protected/ Archaeological/ Heritage sites or Defence establishments or important monuments in the area.
- h. There is no violation reported under the Forest (Conservation) Act, 1980.
- i. The requirement of forest land for the project is bare minimum and unavoidable.
- **4. Report of DCF, Tumkuru Division:** The Deputy Conservator of Forests, Tumkuru Division has inspected the site on 15-02-2023 vide Ref (4) has submitted his report along with Site Inspection Report in PART-II to Conservator of Forests, Hassan Circle. Main features of the proposal based on the reports of the Deputy Conservator of Forests, Tumkuru Division r/w report of Conservator of Forests, Hassan Circle and that of ICT Centre of Forest Department are summarized below.
 - **a.** The forest area proposed for diversion is not vulnerable to soil erosion.
 - **b.** The forest land proposed for diversion is in general landscape of Eco-class-III (Tropical thorn Forest) with a Canopy Density of up to 30 (Open Forest).
 - c. As per Item 4(ii) of PART-II, there are 456 trees in different girth classes. Main tree species include Acacia Catechu, Acacia Nilotica, Albizia Amara, Azadirachta Indica, Bauhinia Parviflora, Terminalia Paniculata, Ficus Benghalensis, Dalbergia Latifolia, Madhuca Indica, Hardwickia Binata, Terminalia Bellarica, Ziziphus jujuba and others
 - **d.** Main wild animals reported in and around the project area include Leopard, Bear, Chinkara & Wild Boar etc.
 - **e.** There are no other rare / endangered / unique species of flora and fauna reported in and around the forest land proposed for diversion.
 - f. The forest land proposed for diversion does not form part of any National Park/ Wildlife Sanctuary/ Biosphere Reserve/ Tiger Reserve/ Elephant Corridor/ Wildlife Migration Corridor, etc.
 - **g.** There are no Protected/ Archaeological/ Heritage sites or Defence establishments or important monuments in the area.
 - h. There is no violation reported under the Forest (Conservation) Act, 1980.

- i. The requirement of forest land for the project is bare minimum and unavoidable.
- 5. CCF, Ballari Circle Report: The Chief Conservator of Forests, Ballari Circle has inspected the site on 09-09-2022and has agreed with the report of Deputy Conservator of Forests Ballari Division. The Chief Conservator of Forests, Ballari Circle vide Ref (4) has submitted his report in PART-III and has also recommended the proposal.
- **6. CF, Hassan Circle Report:** The Conservator of Forests, Hassan Circle has inspected the site on 15-02-2023 and has agreed with the report of Deputy Conservator of Forests Tumkuru Division. The Conservator of Forests, Hassan Circle vide Ref (4) has submitted his report in PART-III and has also recommended the proposal.
- 7. Net Present Value (NPV): The User Agency is required to pay the Net Present Value (NPV) of forest land proposed for diversion as per Para 3.1 to 3.4 of the FC Guidelines communicated by Government of India, Ministry of Environment, Forests and Climate Change, New Delhi vide F.No. 5-3/2011-FC (Vol-I) dated 06-01-2022 and 19-01-2022. The User Agency has submitted an Undertaking agreeing to pay the Net Present Value (NPV) of the forest land proposed for diversion.
- 8. Compensatory Afforestation (CA): In accordance with the provisions of para 2.5 (i)(a) of the FC Guidelines communicated by Government of India, Ministry of Environment, Forests and Climate Change, New Delhi vide F.No. 5-2/2017-FC dated 28-03-2019, the Compensatory Afforestation can be raised and maintained at the cost of User Agency on degraded forest land twice in extent of the forest area proposed for diversion in the cases of widening of roads. Accordingly, the Deputy Conservator of Forests, Tumkuru has identified an extent of 5.0508 had degraded forest land in Dasudi Village Sy No. 114 & 115 of Dasudi Forest, Chikkanayakanahalli Taluk, Huliyar Hobli, Tumkuru District for raising CA and uploaded the KML file, Topo Map, Geo-reference Map along with GPS readings of all corners in PART-II of the proposal and also uploaded the CA Suitability Certificate dated 20-08-2022 in the prescribed format. The User Agency has also submitted an Undertaking agreeing to pay the Compensatory afforestation charges.
- 9. Status of RoFR compliance: In order to meet the requirement of the provisions of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 and Rules 2008 and the FC Guidelines, the User Agency has not obtained/ furnished the (copy of) requisite RoFR Certificate in FORM-I (for Linear projects) issued by the jurisdictional Deputy Commissioner as per Annexure II of the FC Guidelines communicated by Government of India, Ministry of Environment, Forests and Climate Change, New Delhi vide F.No. 5-

2/2017-FC dated 28-03-2019. Accordingly, the User Agency is being informed once again to obtain the said certificate in prescribed format and submit a copy.

Under the above circumstances and agreeing with recommendation of the field officers, it is requested to move the proposal to Government of India for according 'in-principle' (Stage-I) approval under Section 2 of the Forest (Conservation) Act, 1980 for diversion of 2.5254 hectare of forest land in Kenkere Sy. No 278 Chiknayakanahalli Taluk, Tumkur District for Reconstruction of two-lane Road with paved shoulders from Ds. Ch. 442+180 (Ex. Km 448.00) to Ds. Ch. 485+240 (Ex. Km 494.000) of Huliyar to K.B Cross Section and from Km Ds. 532+100 (Ex. Km 533.150) to Ds. Ch. 539+100 (Ex. Km 540.175) from KB Cross to Nelligere section of NH-150A in favour of the Superintending Engineer (Civil), Ministry of Road Transport and Highways (Government of India), Regional Office, Race Course Road, Bengalurufor a period of twenty (20) years subject to submission of RoFR Compliance Certificate in FORM-I (for Linear projects) and the conditions listed in Annexure 'A'.

ANNEXURE-A

- The legal status of forest land shall remain unchanged and it shall continue to be forest land.
- The User Agency shall pay the applicable Net Present Value (NPV), Compensatory, 2. Plantation cost of extraction of trees, land lease rent and any other levies as per the conditions of approval.
- The User Agency shall demarcate the lease area in the manner specified at the time of 3. approval at its own cost.
- The lessee shall not sub-lease, mortgage and hypothecate the forest area. 4.
- The Lessee shall provide signages in appropriate dimensions and kind near the proposed road within forest limits for sensitization of general public towards the forest, wildlife and environmental issues in consultation with the jurisdictional Deputy Conservator of Forests.
- The leased out area should be used for the purpose for which it is granted. In case the land is not used for the stipulated purpose within two years or when it is no longer needed for the stipulated purpose, the area would stand resumed to the Forest
- No change in Land Use Plan on forest land shall be done except with prior approval of Government of India under FC Act 1980.
- The application for renewal of the lease in the prescribed form and manner shall be submitted at least six months prior to the expiry of forest lease. In case no renewal is sought, the Lessee shall hand over the lease.
- No residential or commercial buildings shall be permitted in the forest area proposed for diversion.
- 10. No crushing / breaking of stones or labour camp shall be allowed on forest land and all waste / debris generated shall be scientifically disposed off outside the forest area.
- 11. Any damage to forest area because of implementation of the proposal shall be compensated by the Lessee. The extent of damage shall be assessed by the jurisdictional Deputy Conservator of Forests/ Conservator of Forests/ Chief Conservator of Forests.
- 12. The Lessee shall ensure that no avoidable harm is caused to the fauna and flora in and around the proposed area.
- 13. In case, any violation of the provisions of the Karnataka Forest Act, 1963 & Rules, 1969 or other relevant Acts/Rules is reported during the lease period, the lease will be liable for forfeiture under Section 82 of Karnataka Forest Act, 1963. The Chief Conservator of Forests / Deputy Conservator of Forests concerned are authorized to take necessary action in this regard.
- 14. The approval under the Forest (Conservation) Act, 1980 is subject to any other clearances necessary under the prevailing statutes.
- 15. The User Agency shall also abide by other conditions those may be imposed by the Government of India, Government of Karnataka and Principal Chief Conservator of Forests (Head of Forest Force) before or after the approval.
