SITE INSPECTION REPORT BY AN OFFICER NOT BELOW THE RANK OF DCF/DFO

Proposed diversion area − 4.896 ₹ 0

Forest Block − Khimach A block

1. A proposal has been received by this office from PUBLIC WORKS DEPARTMENT for diversion (under FCA 1980) of 4.896 ha of forest land for non-forestry purpose. The subject envisages the use of forest land for road. The site inspection of the land involved in the proposal has been done by me on **21-01-2025**.

On inspection of the site, it is found that the area of the land required by the UA is **4.896 ha. Protected Forest Block Khimach A. This alignment is an existing road that is blacktopped for the length of 2400 mtrs.** The requirement of forest land as proposed by the UA in col. 2 of part-1 is unavoidable and is barest minimum required for the project.

- 2. Whether any rare/endangered/unique species of flora and fauna found in the area? If so, the detail thereof; No
- 3. Whether any protected archaeological/heritage site/defense establishment or any other important monument is located in the area if so, the details thereof with NOC from competent authority, if required –No
- 4. The UA has violated the provision of the FCA 1980 and black-topping work is done without proper sanction (VIOLATION). The violation is reported to have happened in the year 2007, on the basis of administrative sanction of PMGSY vide order number No.F2(5)/PW/AS/2005D-2577 dated 12-08-2005. Based on the letter of Additional Chief Engineer PWD Zone Kota no. 4040 dated 17-07-2012, the violation work was done from 25-10-2005 till 08-06-2007.

Total measurement of violation = 2400 mtrs length x 10 mtrs width = 24000 sq. mtrs. i.e. 2.4 hectares
