FIELD INSPECTION NOTE OF THE FOREST DIVISIONAL OFFICER, NIZAMABAD ON.13.07.2018, IN CONNECTION WITH THE PROPOSED DIVERSION OF RESERVE FOREST LAND FOR "LAYING OF OPTICAL FIBE CABLE ALONG THE ROAD AND WITHIN THE EXISTING RIGHT OF WAY AT AMSANPALLY AND RAMAREDDY VILLAGES IN NIZAMABAD DIVISION AND DISTRICT

As per the request made by M/s Reliance Jio Infocomm limited ,Raj Bhavan Road, Hyderabad , I have inspected the site for laying of Optical Fiber Cable along the road and with in the right of way passing through Compt.No.422,418 of Amsanpally Reserve Forest and Compt.No.599 of Ramareddy Reserve Forest of Indalwai Range along with Forest Range Officer, Indalwai. The User Agency has requested for diversion of 0.1312 ha of Forest land for laying of Optical Fiber Cable along within the existing right of way between Indalwai to Kondapur.

The proposed alignment is a linear patch passing through the Reserve Forests and the extent is 0.1312 Ha. The User Agency, M/s Reliance Jio Infocomm Ltd., 204 lake Shore Towers, raj Bhavan Road, Somajiguda, Hyderabad, has got the area demarcated on the ground.


I have inspected the site along with the Forest Range Officer, Indalwai and concerned staff and it was observed that there are no Trees are proposed for diversion. The alignment of optical Fiber Cable is passing through the Aasanpally Reserve Forest (C.No.422,418) and Ramareddy Reserve Forest (C.No.599) along Indalwai to Bheemgal R & B Road.

I have searched for alternatives, but there is no other alternative alignment available except the present proposal. This is the barest minimum area that is required for Optical Fiber Cable along the forest adjacent to the existing R & B road between Indalwai to Bheemgal

The issue has been critically examined and found that the requirement of forest land for the above linear project is unavoidable in view of public interest. As per the tree enumeration report given by the Forest Range Officer, Indalwai, there are no trees are proposed to be felled but the user agency gave an undertaking that they will execute the trenching for alignment of OFC manually to avoid tree felling. It is observed in the field inspection that there is no damage to the existing forest cover and wild life, if the said project is approved.

- 1. The area does not fall in wildlife protected areas and there is no archaeological heritage site, important monuments in the proposed alignment.
- 2. The alignment shown in the diversion proposal map was verified on the ground and found that, the alignment passing through Compt.Nos.422,418 & 599 with-in the Right of way of R & B Road i.e., 15 fee from the center of the road and no trees will be effected.
- 3. Detail of right way allowed in Amsanpally & Ramareddy Forest Blocks along with in the optical fiber cable alignment was proposed.
- 4. **Amsanpally RF:** Road width 30 feet as a right of way allowed for Zillaparished road from Indalwai to Dharpally (now R & B Road) as per the notification approved U/s-4 & APFA 1967 vide GO.MS.No.374 E & RD (For-III), dt.30.04.1976 which has been published in the State Gazette no.20c, dt.20.05.1976 (Copy Enclosed).

Ramareddy RF: - Only cart track is allowed in the notification. However the Government of Telangana State, Hyderabad has accorded State-I approval Under Forest Conservation Act,1980 for Diversion of 1.29 ha of Forest Land for Improvement of Indalwai to Bheemgal Single line to double line road with a width of 30 feet vide GO.Ms.No.84 EFS & T (For-II) dtd.27.06.2016

The Proposals for diversion of 0.1312 Ha of Forest land for laying of Optical Fiber Cable along the road and with in the existing right of way) between Indalwai – Bheemgal road are recommended.
