During the 31<sup>st</sup> Meeting of Standing Committee of NBWL held on 12<sup>th</sup>-13<sup>th</sup> August 2014 under the chairmanship of Hon'ble Minister of State (Independent Charge) for Environment, Forests and Climate Change, the following proposal pertaining to your State was considered. The relevant portion of the decision taken in respect of the proposals is reproduced below:

## "I. Denotification of Abubshehar Wildlife Sanctuary, Haryana.

The Member Secretary briefed the Committee regarding the proposal. The matter was considered earlier wherein the state of Haryana was requested to consider notifying the proposed area as a conservation reserve. The representative of Government of Haryana informed the Committee that the State Government was agreeable to notification of a Community Reserve in lieu of the Sanctuary.

After discussion, the Standing Committee decided to recommend the proposal for denotification of Abubshehar Sanctuary with the condition that it be notified as a Community Reserve."

The above recommendation(s) are subject to the existing directives of Hon'ble Supreme Court and provisions of Forests (Conservation) Act, 1980.
