The Executive Engineer, TDWSP Division, Kothagudem vide Lr.No.AEE/Forest/RoFR/Kothagudem - 2016, dated: 20.08.2016 has submitted application stating that the work of Mission Bhageeradha, Godavari Sigmet viz., laying of pipe lines and construction of sumps and GLBRs is under progress in Palvanvcha & Manuguru Sub-Divisions and forest permissions are required to execute the specified works as there is forest land in which the works are executing and further informed that a certificate from the Chairman (District Collector & District Magistrate, Khammam) of the District Level Committee appointed under RoFR Act 2006 is required for approval and requested to conduct the SDLC in order to ascertain the status of RoFR claims pending if any for getting the needed clearance from the Forest Department of the above sigmet.

Accordingly, the Revenue Divisional Officer, Kothagudem has explained the issues involved and the purpose for which the Sub-Divisional Level Committee meeting conducted. As seen from the proposals submitted by the Executive Engineer, TDWSP Division, Kothagudem, it is noticed that in which the works to be executed are located in Chathakonda Forest Range covering in Kothagudem and Gundala Mandals of Kothagudem Division and the area involved in the proposed works comes to 4-334 Ha in various compartments of Palvanvcha (Wild Life) Forest Division. The particulars of the location of the works are enclosed separately.

It is further noticed that the Gram Panchayats of Regalla, Mylaram, Bangaruchalka in Kothagudem Mandal and Gram Panvhayats of Ananthogu, Allapalli, Markodu of Gundala Mandal have passed the resolutions stating that no RoFR claims are pending and no encroachments have been detected in the given compartments and finally consented to grant the necessary clearance to the user agency as per the procedure and the same resolutions are also appended herewith. The Forest officers who have attended the meeting have also agreed with the resolutions passed by the above Gram Panchayats.

Basing on the resolutions passed by the above Gram Panchayats and concurrence given by the committee members who are present in the meeting, the Sub-Divisional Level Committee under the Chairman ship of the under signed has passed the resolution stating that no objection for the proposed diversion of forest land to an extent of 4-334 Ha in the enlisted compartments in Chathakonda Forest Range of Palvancha (Wild Life) Forest Division for execution of the works pertaining to "Mission Bhageeradha" in Godavari sigmet. This resolution is submitted before the District Level Committee for subsequent issue of a certificate in Form-1.



In this connection, the Tahsildar, Palvanha & Pinapaka are submitted that.. they are inspected personally proposed forest lands in their jurisdiction along with Executive engineer, TDWSP Division, Kothagudem, local forest officials and it was found that there are no encroachments in said forest land, no cultivation or any occupation in the proposed forest land for Laying of Water grid pipe lines, Approached road & construction of Head Works under mission Bhageeradha situated at situated at Regalla forest beat area of Pinapaka Mandal & Yanambail, Karegattu Forest beat area of Palvanha Mandal wild life forest areas and also convened the meeting of Gramasabhas in the above said (4) G.Ps under the Chairmanship of Sarpanches, Gramapanchayat Secretaries concerned G.Ps along with Chairman Forest Rights Committee, IKP Members and passed the resolution stating that they have no objection for diversion of the said forest land to the department of TDWSP Division, Kothagudem for Laying of Water grid pipe lines, Approached road & construction of Head Works under Mission Bhageeradha., and also no claims have been received for Individual or Community purpose for Recognition of Forest Rights over the proposed forest land, hence no Rights are recognized so far and no claims are pending as on date in the proposed forest land and their Rights are not getting affected.
