Sir,

With reference to the above mentioned subject the compliance of EDS raised by your good office has been done. The details are mentioned below:

S. No.	EDS Raised on Proposal	Compliance of EDS by User Agency
1.	Detailed muck disposal plan/land reclamation plan with financial implications.	This has been prepared as per the direction given by Regional Office MoEF&CC, IRO Jammu and attached as Appendix- I.
2.	Permanent / Regular employee is shown as 1000 Justification Required.	It was erroneously mentioned as 1000 for 100 the same may kindly be noted as 100. The project road Chenani-Sudhmahadev NH- 244 is an important strategic road from Defence point of view. Presently it is being developed into two lane configuration and after completion of this project to maintain the project road man power is required. As per present situation the forest diversion at two locations where bridge is going to be constructed in hilly area which requires lots of man power for cutting, filling and construction work. This area is also snow bound therefore, during winter season man power will be required to clear the road for Local People and Army Personal to reach at their locations. Hence, in online proposal of forest clearance Permanent / Regular employee should be shown as 100 (approx.) which are needed during construction and post construction phase (maintenance) of the project.
3.	KML of the proposed site is significantly bigger than the proposed area of 5.146 ha. Revised KML of project site to be submitted.	KML of the proposed site is not bigger than the proposed area of 5.146 ha. It is an exact measurement. In the file it is shown in green thick line which was measured during joint survey from Start Chainage to its End Chainage. Also, if the proposed KML File will be split from left side menu details can easily be seen. As per Compliance of EDS New Revised KML file of Project site is being submitted through a CD enclosed.
