Budang-Zoom RF Area= 0.63 ha. Zoom RF Area= 0.18 ha. Zoom RF Area = 0.03 ha. Zoom RF Area = 0.036 ha. Chumbong RF Area= 0.72 ha. Mendo RF Area = 0.66 ha. Soreng RF Area =1.2 ha.
