2. The point-wise reply with regard to observations raised by the GoI vide letter under reference is submitted in an annotated manner hereas under:-

	i) As per clarification of MoEF & CC guidelines dated 24.01.2022 regarding non-sire-specific activity it has been clearly mentioned that, "Utilization of forest area for establishing industries, construction of residential colonies, institutes etc. are non-site-specific activities and cannot be considered on forest land as rule". Therefore, the State Government may explore non-forest land for the extant proposal.  ii) Since this is a non-site specific project the State Government must explore the alternatives in more details and must give complete	i) It is submitted that as per Govt. of India MoEF & CC Guidelines dated 24.01.2022 the land proposed for the construction of Sub Divisional Soil Conservation office building is non site specific activity for which user agency has given a detailed reply. The same is reproduce as under:-  It is submitted that the Sub Divisional Soil Conservation office building is proposed to be constructed in village Bagsiad, District Mandi. Village Bagsaid is located in a remote locality of District Mandi and majority of population in the area is dependent on agriculture and horticulture produce. Landholding of the villagers is very small, as such private land is not available for construction of the same. Most of the government land falls under the category of Forest land. Hence, construction of the office building has been proposed on the forest land since no other land is

available for this construction. Use of forest land is unavoidable and bare minimum forest land is proposed to be diverted. Three alternatives were explored and the most suitable site selected for diversion. Detailed justification note is uploaded online (copy attached for ready reference).

It is also clarified that the proposed diversion land is only for the purpose of construction of office building and no other such activity is being carried out, that has been mentioned under MOEF letter No. FC-11/155/2020-FC dated 24.01.2022 that is establishing industries, construction of residential colonies, institutes, disposal of fly ash, rehabilitation of displaced persons, etc.

In accordance with the MoEF & CC guidelines dated 24.01.2022 the user agency has submitted the layout plan of the site, land use, land cover map of Soil Conservation Office as well as detailed map of the site and component wise utilization of the land. In view of the reply and documents submitted by the user agency the land proposed for the construction of Sub Divisional Soil Conservation office building at Bagsaid is not non site specific activity, the proposed land be considered for the diversion of 0.0869 ha. of forest land for the construction of Sub Divisional Soil Conservation office building at Bagsaid.

ii) As per the directions issued by the MoEF & CC Guidelines the user agency had explored 3 alternative sites and selected on spot for the construction of aforementioned project on the Govt. Forest land the site wise detail of the same is given as under:-

Three sites were explored as per detail given below:

1. Proposed Site - 'This site involves 0.0869 ha of forest area. No tree felling is involved in this patch of forest land. Proposed land is suitable for office purpose since it is easily approachable, involves minimum area and no tree felling.

2. Alternate Site 1 - This site involves forest area of 0.1488 ha and 28 number of trees which is much

higher than the proposed site.

3. Alternate Site 2 – This site involves forest area of 0.1581 ha and 34 number of trees which is significantly higher than the proposed site.

If the area of muck dumping site has not been included in the proposed Diversion Area, the same may be included and accordingly Diversion Area may be revised.	that the 40 Cum of muck will be dumped at Khasra No. 538/1 of 00-02-00 Bigha (0.0080 Hect), which is marked by name "Existing Dumping Site" in KML file. This land is part of total land involved for diversion that is 0.0869 Hectare. There is no need of any private land for this purpose and so it has not been marked in KML. Therefore, the revised muck management plan has been uploaded online and copy of the same is enclosed herewith in duplicate.
5	From the KML file of proposed diversion area it has been observed that some construction of permanent structures have been done violating the provisions of FCA, 1980.	User agency has reported that earlier Geo Coordinates of the proposed site were marked inadvertently and the KML file was showing some construction of a permanent structure in the proposed area. Now, the KML file has been corrected and uploaded in Parivesh-I portal at appropriate place. At present no structure is existing on the proposed area.
6	In Part-II, relevant documents and KML file of proposed Compensatory Afforestation (CA) area has not been provided at para 13. Therefore, all the relevant documents related to CA and KML file shall be uploaded to para 13.	KML file of proposed Compensatory Afforestation (CA) area has been uploaded in Parivesh Portal-I at para 13.
