In this regard, it is intimated that the Board has no objection for issuance of NOC, as sought by the applicant from your office, for setting up of a new CNG Retail Outlet of IRM Energy in Khasra no. 17/2/1, 17/2/2, 17/2/3 (as per site submitted by the project proponent) subject to following conditions:

1. The owner/operator of the CNG retail outlet shall comply with the guidelines laid down by the CPCB vide its office memorandum no. B-13011/1/2019-20/AQM-10802-10847 dated 07.01.2020 for operation of this retail outlet.
2. The owner/operator of the CNG retail outlet shall obtain consents from the Board under Green category under the Water (Prevention & Control of Pollution) Act, 1974, the Air (Prevention & Control of Pollution) Act, 1981 and authorization under the hazardous & Other Waste (Management & Transboundary Movement) Rules, 2016 before commissioning the outlet.
3. The company shall obtain license from the explosives department & submit the same to the Board before starting the outlet.
4. The company shall submit onsite emergency plan to the Board before starting the outlet.
5. The company shall comply with the provisions of the Manufacture, Storage & Import of Hazardous Chemical Rules, 1989.
6. The company shall not store CNG beyond the threshold quantity as mentioned in the Manufacture, Storage & Import of Hazardous Chemical Rules, 1989, in case the company stores CNG beyond the threshold quantity, the company shall be



liable to obtain Environmental Clearance under EIA notification dated 14/09/2006.

7. The D.G set to be installed must have inbuilt acoustic enclosure (canopy) as per the MoEF notification No. GSR 371(E) dated 17.05.2001 and guidelines prescribed by the Punjab Pollution Control Board from time to time to contain the concentration of sound pressure level within the prescribed standards and shall comply with the emission norms fixed by the MoEF/Punjab Pollution Control Board from time to time.
8. The company shall get itself covered under Public Liability Insurance Act, 1991 and submit the copy of the same to the Board before starting the outlet.
9. The company will not install any service station without prior written permission of the Board.
10. The company shall provide paved entry/exit of the retail outlet.
11. The company shall obtain NOC from Forest Department for cutting down of trees and shall cut down minimum no. of trees only and shall plant at least equal no. of trees at available land.
12. The NOC is valid in case proposed site is suitable as per bye-laws of Master Plan, if the site falls within the limits of the Master Plan or Zoning Plan of GMADA.

The company shall also bound to obtain permissions required from the various departments, if any.
