So detailed survey of existing roads have been done for laying of underground the OFC duct & cable within ROW of road SH-139 & SH-140, where the maximum area will be covered for mobile network, and also easy maintain for long period. The Company as applied to do work within the ROW of road as per resolution issued by the Govt. of Maharashtra. Public works Dept. The Executive

Engineer, Public works (West) Division, Satara has sanction permission by Reference no-EP4710 & EP4902. for laying of underground OFC duct & cable within the ROW of existing road. As same part of existing road SH-139 & SH-140 passing through the Forest Land at village Vatambe, Mukawale, Machutar, Shindola. Ta-Jawali & Mahabaleshwar, Dist-Satara. As same part of existing road passing through the Forest Land, and there need the prior permission from competent authority for Laying of underground OFC duct & cable within the Row of the existing road SH-139 & SH-140, passing from the forest land in Satara Dist. is as under,

The OFC cable will be laid by digging trench of size 10 mt. wide and depth below 1.40mt. & in one trench two duct pipe will be laid, & out of which one duct pipe is use for OFC cable. After laying of pipe the trench will be refilled. In this work there is no need to cutting of trees for this works


Project authority submits that, cost of C.A. may not be levied in this proposal as the proposed laying of OFC cable within RoW of existing road, road passing outside National Park & WL. Sanctuary area & no need to cutting of trees, which fulfil the conditions given in MoEF & CC guideline no FC-11 /165/2019- FC, Dt. 27<sup>th</sup>. July 2020

There is no alternative other than proposed alignment, & the required forest land for laying of underground OFC cable is barest minimum. Project Authority will start work on forestland after sanction from State Govt. Hence this proposal is submitted for sanction under F.C.A, 1980.

Hence this proposal is being submitted for necessary clearance under the provision of the Forest (Conservation) Act, 1980

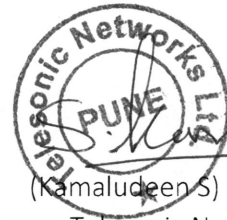
