At an outset the Revenue Divisional Officer, Kothagudem has welcomed the above officers attended to day i.e. on 11.02.2016 at 4.00 PM in the chamber of Revenue Divisional Officer, Kothagudem for Sub Divisional Level Committee (RoFR) meeting.

The Revenue Divisional Officer, Kothagudem has explained the issue of Sub Divisional Level Committee (RoFR) meeting conducted that (i) diversion of 19.2096 HA of forest land at Chathakonda RF block for erecting of 400KV QMDC Line from 4X270MW Bhadradri TPP Manuguru to 400/220 KV QMDC SS Julurupad (ii) Extent of 18.5334 HA forest land in Chathakonda RF for erection of 400KV QMDC Line from 800MW KTPS-VII stage Paloncha to the proposed 400/220KV SS Julurupad.

The Tahsildar Kothagudem has informed that he has personally inspected the proposed forest land on 30.01.2016 along with Executive Engineer 400 KV TRANSCO Warangalk, Local Forest officers and it was found that there are no encroachments in said forest land, no cultivation or any occupation in the proposed forest land proposed for (i) diversion of 19.2096 HA of forest land at Chathakonda RF block for erecting of 400KV QMDC Line from 4X270MW Bhadradri TPP Manuguru to 400/220 KV QMDC SS Julurupad (ii) Extent of 18.5334 HA forest land in Chathakonda RF for erection of 400KV QMDC Line from 800MW KTPS-VII stage Paloncha to the proposed 400/220KV SS Julurupad.

The Tahsildar has convened the meeting of Grama Sabha on 30.01.2016 in Gram Panchayat office Regalla in which local forest officers, officers from user agency, Chairman Forest Rights Committee have present and the villagers have expressed that there are certain encroachments in the proposed extent of the land for (i) diversion of 19.2096 HA of forest land at Chathakonda RF block for erecting of 400KV QMDC Line from 4X270MW Bhadradri TPP Manuguru to 400/220 KV QMDC SS Julurupad (ii) Extent of 18.5334 HA forest land in Chathakonda RF for erection of 400KV QMDC Line from 800MW KTPS-VII stage Paloncha to the proposed 400/220KV SS Julurupad in which Transmission towers will be erected by user agency and the same issue was conveyed in the Grama Sabha Resolution.

In order to examine their objections, the Dy.Tahsildar (RoFR) ITDA Bhadrachalam has taken the applications from the (30) applicants and survey of the land has been carried out in the presence of the applicants and forest officers. Finally, the claims of the individuals are rejected

as their encroachment of the land was took place after the year 2005 and the applicants have not furnished any evidence in support of their claims.
