## ORDER:-

Vide reference read above, the Chief Engineer (R&B) MDRs & ORS, NABARD & LWF, A.P., has stated that the work "Formation of Ghat road on Kondaveedu fort hill top to reach the guest house and temples in Edlapdu Mandal, Guntur District" which was sanctioned for Rs. 34.00 Cr vide G.O.Rt.No1011, TR&B(R.IV) Dept., Dt.02.11.2010 is nearing completion. This work was sanctioned to develop the fort has a hill resort and as a tourism place near the new capital of Andhra Pradesh. Now to reach the plain land and old temples etc., the road has to be extended by forming road further to a length of 660m from the end point of the newly laying Ghat road. The proposed road length is 660 Mts with a land width of 15 Mts to restrict the diversion of Forest land to 1.0 hectare. He has also stated that, Kondaveedu Fort is a famous Historic place with temples, River tanks and other places for tourism and after completion of the road, the visitors can reach the palne land on Kondaveedu Fort where old temples water tanks, Guest houses and old structures are available. Further developments also can be taken up by the other departments like Tourism, Endowments, Archaeology and Electricity departments. He further stated that, it can be a future Hill station to the Capital city of Amaravathi and can generate revenue to the Government. Accordingly, he has submitted an estimate for Rs. 11.80 Cr. for the work "Formation of Ghat road on Kondaveedu fort hill top to reach the guest house and temples in Edlapdu Mandal, Guntur District" after reconnaissance survey, with SSR 2016-17 and requested for according administrative sanction for the said work under Plan MDR.

- 2. In the circumstances reported by the the Chief Engineer (R&B) MDRs & ORS, NABARD & LWF, A.P., and after careful examination of the matter, Government hereby accord Administrative Sanction for an amount of Rs. **Rs.1180.00 Lakhs** (Rupees Eleven Hundred and Eighty Lakh only ) for the work "Formation of Ghat road on Kondaveedu fort hill top to reach the guest house and temples in Edlapdu Mandal, Guntur District" under Plan MDR.
- 3. The amount sanctioned in the Para (2) above, shall be met from the Head of Account "5054 Capital Outlay on Roads and Bridges 04 District and Other Roads MH.337 Road works GH.11 State Development Schemes– SH (09) Major District Roads –530 Major Works 531 Other Expenditure".
- 4. The Chief Engineer (R&B) MDR, Vijayawada, A.P., shall take further action accordingly.
