DETAILED REPORT ON VIOLATION OF PROVISIONS OF FOREST ACTS

The diversion case started when a application received from Sh. Prashant Sagar, Assistant Vice President, IRM House, Kalpana Society, Near Sardar Sewa Samaj, Off. C.G. Road, Navrangpura, Ahmedabad - 380009 for Diversion of 0.0244 ha of forest land permission for construction of approach Access CNG Station of IRM Energy Private Limited at (Sirhind-Chunni Road KM 1 to 2 R/s) Vill: Attewali Tehsil & Distt: Fatehgarh Sahib. The above application endorsed to Forest Range Officer, Sirhind for site inspection along with map of the site. Forest Range Officer, Sirhind has reported to this office that 0.0244 hac. forest area will be affected by this diversion and the user agency has violated the act by using 14 Sqmtr on Sirhind-Chunni Road KM 1 to 2 R/s prior approval of G.O.I. Forest Range Officer, Sirhind has issued a damage report No. 1683250 dated 10.11.2021 against the user agency under Indian Forest Act 1927 and the user agency has deposited the penalty. Penal compensatory afforestation may be imposed on the user agency before issuing the final NOC. After carefully examining the KML file of the project site it was found that the violation was committed by the user agency before obtained the NOC from the Fire Station Officer, Fire Station, Mandi Gobindgarh on 31.12.2019, the case is **"recommended for approval with ten times penal CA"** as per para no. 4 of proceeding received by PCCF letter No. 16133-35 dt. 5-8-2009.
