Subject:-Regarding the issue of "Land Suitability Certificate" for Compensatory afforestation (CA) land given by the user agency as compensatory area for the Diversion of 4.5769ha of Forest land in Sy No 12of siriyur village in BhadravathiTq, Shivmogga dist. According to the site inspection done by Assistant Conservator of Forest, Channagiri Sub-division, Bhadravathi and Range forest officer, Bhadravathi range, Bhadravathi:-

The non forest land parcel(s) show in the table below proposed by Executive Engineer, PWD Department, Special division, Shivamogga District. (User agency) for raising compensatory afforestation (CA) for forest land diversion proposal number FP/KA/ others/141683/2021 for diversion of 4.5769ha of Forest land Siriyur village in Sy.No.12 of Jedikatte Sate Forest at Bhadravathi Range in Bhadravathi forest division.

Remarks:-

- I. The proposed CA Plot-I area is in Sy No.2 of Emmedoddi village, Kudligere hobli, BhadravathiTq, Shivamogga Dist (10.01Acres). It is a Revenue land and it is mentioned as "Sarkari Banjaru" in RTC Colum No.9
- II. The proposed CA Plot-II area is in Sy No 3 of Emmedoddi village, Kudligere hobli, BhadravathiTq, Shivamogga Dist (7.38Acres). It is a Revenue land and it is mentioned as "Sarkari Banjaru" in RTC Colum No.9
- III. The proposed CA Plot-II area is in Sy No 4 of Emmedoddi village, Kudligere hobli, BhadravathiTq, Shivamogga Dist (7.06Acres). It is a Revenue land and it is mentioned as "Sarkari Banjaru" in RTC Colum No.9
- IV. The proposed area for CA land Contains grown tress, This CA Plot-1 Plot-2 and Plot-3 area is a dry deciduous forest and the major species found here are Dalbergia latifolia, Tectona grandis, Terminalia paniculata, Pterocrpus marsupeum, Small bamboo, Lagestroemia, lanceolata, Terminelia ballarica and Anogueisis latifolia etc.,

- V. The proposed area is adjacent to the Dodderi Minor Forest. (Emmedoddi village Sy.no.8) and corridor of wild animals like Elephant, Leopard, wild Gaur, Bear, wild boar, deer, sambar and monkeys etc.
- VI. This proposed land is plain area with gentle slope.
- VII. Annual rain fall here is 600mm to 700mm and this area do not have any channels/tanks.
- VIII. The proposed CA land is adjoining to Emmedoddi village and also adjoining KUSF and Dodderi MF.
- IX. Proposed CA land is 0 meter from Dodderi MF [Emmedoddi village Sy.No.8] (No.G.2362-Fim 109-27-81, Dated 23rd August 1929), and KUSF [Emmedoddi village Sy.no.5] (Notification(i)No.GL.23836-R, 8466, Dated 19th June 1896).
 - X. The proposed CA land is not included in any section-4 proposed area or in Statutory forest proposal list and it is purely revenue land.
- XI. The proposed CA land is free from encroachments, roads and private buildings.
- XII. The proposed CA land in Plot-1 of Emmedoddi village Sy. No. 2(10.01Acres), plot-2 of Emmedoddi village Sy. No. 3(7.38Acres) and plot-3 of of Emmedoddi village Sy. No. 4(7.06Acres) consists of natural forest.
- XIII. The proposed CA land is not a Notified forest.
- XIV. The canopy density of proposed land is above 0.40.
- XV. The proposed CA area consists of natural forest, so here it is not possible to raise plantation of 1000 seedlings per ha. hence Artificial Natural Regeneration (ANR) model plantation with 400 Plants/Ha. And SMC works can be raised.
