III. Technical Details:- Technical details of Compensatory Afforestation Scheme are as follows:-

- i. **General Details:-** An area of 16 Ha will be taken up for planting under compensatory Afforestation scheme in compartment No 103/D, Sudhmahadev Conservation Reserve in a single compact block. The proposed CA site shall be treated by way of planting of Conifers, fruit & fodder species and associated board leafed species (subject to site specific choice of species) and dibbling of HC Nuts site-specific in intermittent patches as well as fencing.
- ii. **Plantation Method:-** Nursery grown one year to three old plants of Conifers, broadleaved species and Fruit plants in Polythene bags/ Naked Roots will be planted in 45cmx45cmx45cm pits in the selected area. HC Nuts will be dibbled in the intermittent portions/ patches. The plantation will be maintained for subsequent 10 years in which beating up causalities will be done. The plantation will be rain-fed.
- iii. **Spacing:-** 3mx3m in staggered fashion.
- iv. **Species proposal to the planted:-** Conifers, fruit & fodder species and associated board leafed species (subject to site specific choice of species) and dibbling of HC Nuts as per site-specific suitability.
- v. **Silviculture Operation:-** Treatment of open degraded blanks to be taken under CA.
- vi. **Soil and Moisture Conservation Works:-** Required as per site specific conditions.
- vii. **Protection (Fencing, Watch man, People's Participation etc):** The fencing with Square PCC post with GI barbed wire is proposed under CA.
- viii. **Proposed Monitoring Mechanism:-** The plantation will be monitored as per existing monitoring mechanism in the department.

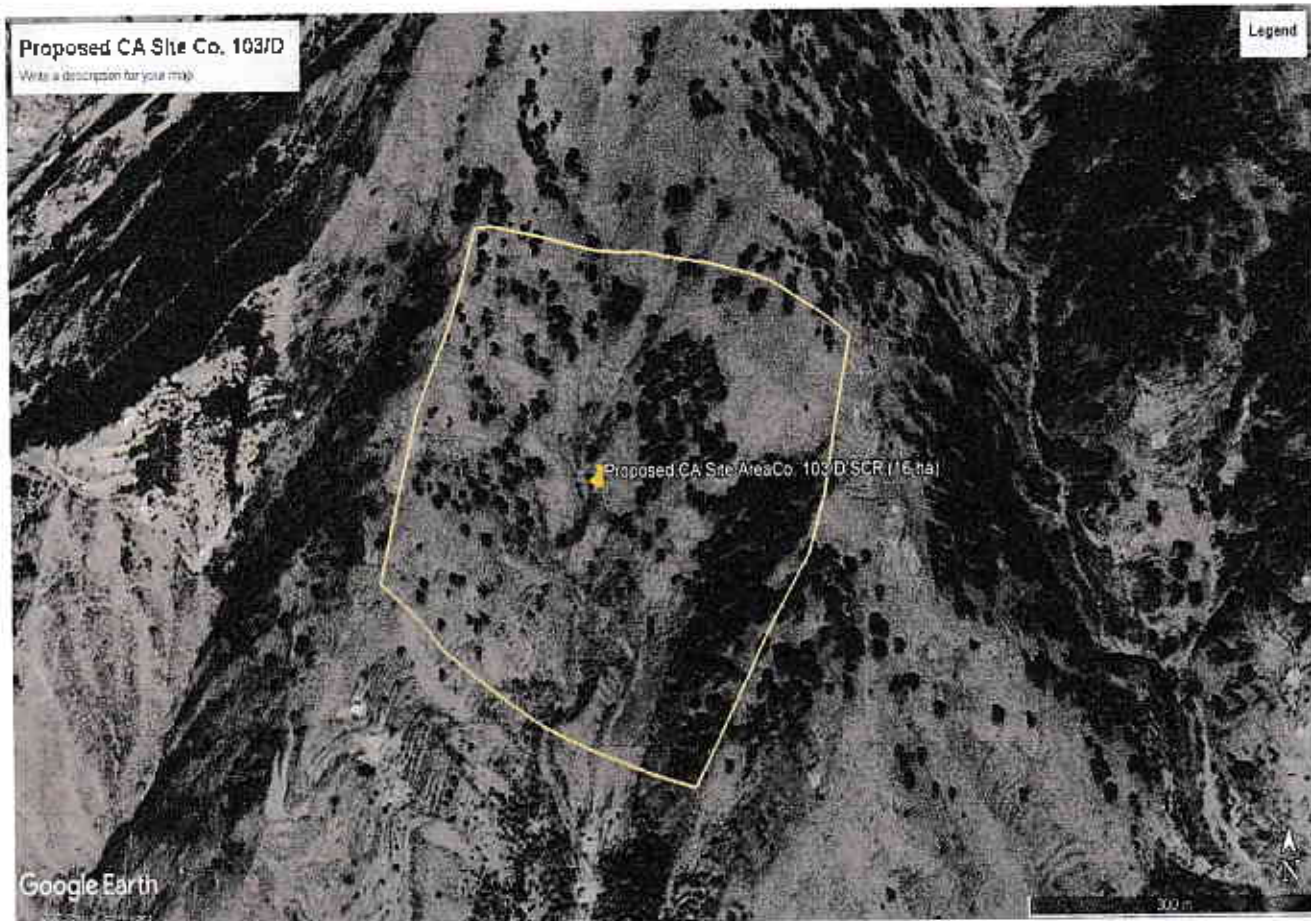
