1. Project Details:

(i) Short narratives of the proposal and project/scheme for which the Forest land is required.

The Rural connectivity road connecting the habitation of NSH Via Tadong to Upper Phodong has been a long pending demand of the local residents and public of the concerned area. Based on the demand, the project was placed and subsequently sanctioned during the financial year 2016-17 under the PMGSY Phase XI. The proposed road has a sanctioned length of 2.480 KM and the total cost of the project is Rs 198.41 Lakhs. The proposed alignment mostly passes through private land, while a stretch of approximately 202 mtr falls within Forest Khasmal.

- (ii) Map showing the required forest land, boundary of the adjoining forest
- (iii) Cost of the project:
 The Total Cost of the Project is Rs 198.41 Lakhs
- (iv) Justification for locating the project in the forest area:

 There were obligatory points like the public crematorium along the alignment which were required to be connected on priority. The Forest Khasmal land is located just below the Crematorium shed, hence the alignment had to be proposed. The alignment passes through the plot no 398,397/986,393,121 which is forest khasmal as per land revenue suvery record 1977-78. The joint inspection and enumeration list has been enclosed.
- (v) Cost benefit analysis:

 The project is for providing rural connectivity to the people of Upper Tadong & Rongong and it is hoped that once there is road connectivity the rural population of this village would be greatly benefitted economically and socially.
- (vi) Employment likely to be generated:

 The scheme will generate employments for the local public in a large scale both in terms of skilled and unskilled laborers.
