Now therefore in exercise of the powers conferred by the provision to the aforesaid sub-section and by sub-section (1) of said section, read with the section 80-A of the aforesaid Act, the Governor of U.P. is pleased to declare that pending such inquiry and record the provisions of Chapter IV of the said Act to be applicable to the lands specified in the Schedule here to:-
