NOC for development of proposed retail outlet of Hinustan Petroleum Corporation Ltd. on Hodal-Punhana-Nagina Road (MDR-131), at RD 12226M (LHS), in plot with Khasra No. 87//8/1 at village Singar, Tehsil Punhana, Distt. Mewat (Haryana)

Your good office letter No. 1896-1906/PLA dated 02/12/2015.

As desired vide your letter under reference No Objection Certificate to HPCL is hereby given by this office at Hodal Punhana Nagina Road, Tehsil Punhana, District Mewat at RD 12226 Mtr. (LHS) subject to the following terms and conditions.

1. The applicant have fulfill all condition of the department/IRC:12-2009 instructions/guidelines.
2. The proposed retail outlet falls on Hodal Punhana Nagina Road, Tehsil Punhana, District Mewat and it has been decided that drawing of proposed retail outlet should be got corrected and amended from the applicant in respect of plinth level building/Shoulder of the road level which should be at least 300mm below the road level.
3. There should be no hindrance to the traffic if petrol Pump is provided.
4. The side drain will be constructed by the owner to drain out the water at his own cost.
5. The level of the service road/plate form will be kept 6" below from the existing road level.
6. The buffer strip should be constructed in his own land by the agency.
7. That only the slab type culvert with iron grating of adequate strength shall be constructed in the access so that surface water drained through the opening of the gritting.
8. Proper submitted/alternative arrangement of H.T. line exist along the PWD B&R road, be made as per requirement of DHBVN Mewat.
9. The applicant should construct the service road of length 253.40 Mtr. road 7.00 Mtr. wide +70 Mtr. declaration lane + 100 Mtr. acceleration lane at his own cost as per cross section of road approved
10. In case of Wdg. of main road by department the applicant will dismantle the service road at his own cost and nothing will be paid by department for it.
11. This is provisional approval for a year. Regular NOC will be issued after installation of the retail outlet after final site inspection.


