Sub:-Approval of Mining Plan of the Permit Blacktrap submitted under Rules of GMM for the Permit of Blacktrap mineral over an area of 01-00-00 Hectors Survey/Block.no:- 458(Private) of Village- Tuked, Taluka- Mand (Gujarat).

In exercise of the power conferred vide Government of Gujarat Notification No.MMR/102014/979/CHH dated 18/07/2015 and letter No.: MMR/102014/979/CHH dated 30/07/2015 from Industries and Mines department, Govt. of Gujarat read under Rule 35 TO 39, 60 TO 62, 64, 67 of GMMCR, 2017, I hereby approve the above said Mining Plan. This approval is subject to the following conditions:

- The Mining Plan is approved without prejudice to any other laws applicable to the mining Permit from time to time whether made by the Central Government, State Government or I.
- This approval of the Mining Plan does not in any way imply the approval of the Government in terms of any other provisions of the Mines & Mineral (Development in II. Regulation) Amendment Act, 2015 and rules made there under and any other laws including the forest Conservation Act, 1980, Environment Protection Act, 1986 and the rules made there under. In is clarified that this approval of Mining Plan is subject to the forest (Conservation) Act, 1980, Forest Conservation Rules, 1981 and other relevant statutes, orders and guidelines as may be applicable to the PERMIT area form to time.
- That the Mining Plan is approved without prejudice to any order or direction from any III. court of competent jurisdiction.
- Provisions of the Mines Act, 1952 and Rules and Regulations made there under including submission of notice of opening, appointment of manager and other statutory officials as IV. required by the Mines Act, 1952, and sub-sequent rules shall be complied with.
- The execution of mining plan shall be subjected to vacation of prohibitory orders/ V. notices, if any.
- The lessee shall submit "Financial Assurance" under Rule 64(i) GMMCR, 2017 before executing the Permit deed. The mining operation cannot be commenced before VI. submission of financial assurance to the competent authority.
- If anything is found to be concealed as required by the Mines Act in the contents of the VII. mining plan and the proposal for rectification has not been made, the approval shall be deemed to have been withdrawn with immediate effect.

- As regards to mining operations and blasting is concerned, the lessee has to follow VIII. provisions of Metalliferous Mines Regulations, 1961 and directives issued by Director General Mines Safety from time to time.
  - This approval is as per the detail/Plan submitted by your RQP. Any deviation from actual IX. submission will be subject to immediate rejection of the Mining Plan.
  - The applicant shall have to provide the details of renewal of mining Permit including date X. of renewal whenever order to the effect with respect to area of Permit and mineral covered in the above Mining Plan received from State Government.
