This place is a main business centre for south and west district of Sikkim, with a population of 9009 as per the report released by the Census India 2011. Being a main business centre population of Jorethang town is increasing day by day and till date there is no proper set up for sewerage treatment. Therefore the need for a new sewerage treatment plant is of utmost importance.
