
Reference is invited to the requirement of submission of status of settlement of rights under the Forest Rights Acts, 2006 on the forest land proposed to be diverted.

Sir,

Mr. R.Banerjee, Director (Projects), NPCIL met me today and requested me for the following matters which need to be expedited by you with regard to the upcoming 4x770 MW Nuclear Power Plant in Banswara:-

- a) Disbursement of award money: As informed by you telephonically, compensation amount for 4 out of 6 villages has been disbursed and for the remaining 2 villages, the amount will be disbursed by the end of this month. You are requested to kindly ensure the same.
- b) Revision of R&R package: The R&R package for some beneficiaries needs to be revised, for which action has already been initiated and is to be sent to GoR for approval. It was informed by you that this will be done within 6 weeks.
- c) Transfer of government land for the power plant: It was informed that the proposal had been sent to Revenue Department. Some queries have been raised by the Department and they will be replied. This may kindly be expedited.

- d) Identification and allotment of land for R&R colony: As informed by you the land has been identified and proposals have been recently sent to Revenue Department. You may kindly follow up with the Revenue Department for early allotment of the land.
- e) Diversion of forest land: Some forest land is also coming in the site of the proposed Nuclear Power Plant. It was assured by you that the FRA certificate shall be issued within this week.
