

As per the comment's raised in REC meeting held on 27 March 2018, the NHAI has duly complied all the condition-imposed in stage - 1 as well as in stage - 2. However REC raised the concern about the point no.- ix of a MOEF & CC final approval vide file no. F.NO. 8-16/2012-FC dated 9<sup>th</sup> may 2013 for NH-91.

The NHAI here with undertake that strip plantation will be raised in proposed bypass for package-1 , length 6.64 km , for package-2 , 15.2 km and for package-3-14.79 km , where in width 7.5m strip on both side of length is available .


Plantation will be carried out as per IRC SP. 21/2009.
