With reference to your letter no. as cited above, I have the honour to state and clarify that, a joint Re-inspection of the proposed diversion land at Lungdingkro village has been conducted by the Range Officer, Langting Range alongwith the Revenue Officials of N.C. Hills Autonomous Council, Haflong to verify the status of the C.A. Land.

On joint verification of the proposed diversion land, it has been observed that the Geo-Coordinates of the C.A. land actually falls within the LMRF areas. As reported by the Range Officer, Langting Range there might be some malfunctioning of the GPS Hand set at that point of time. The co-ordinates were recorded in a situation wherein there were heavy rainfall in that area on that particular date.

However, a fresh GPS co-ordinates has been recorded jointly with the Revenue Officials in the exact location at Lungdingkro village on the bank of Lungding river under Langting Range which has been authenticated by them to be in the outside of LMRF area. The proposed C.A. land is suitable enough for the purpose of compensatory afforestation.

The error has occurred due to erroneous inputs of Geo-co-ordinates in the earlier occasion for the reason as stated above. Copy of Re-verification report of Range Officer. Langting Range, Google Map with Geo-co-ordinates of the proposed C.A. area and kml file are enclosed herewith for the purpose.


